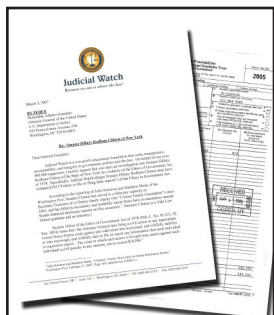

## HILLARY FILES FALSE FINANCIAL DISCLOSURE FORMS

Judicial Watch filed separate complaints with the Senate Ethics Committee and the Department of Justice against Hillary Clinton, who failed to disclose her position as Secretary/Treasurer of the Clinton Family Foundation in Senate financial disclosure reports on five occasions, in violation of a federal law called the Ethics in Government Act. Why would Hillary want to keep her role in the foundation a secret? Apparently, there is a foundation contribution concerning an individual involved in Hillary's questionable commodities trading in the 1970s. Certainly as she prepared for her presidential run, Hillary had an interest in keeping from the public more questions about cattle futures and the foundation's contributions to Mideast charities. In classic Clinton fashion, Hillary said her failure to report the lucrative family charity in Congressional disclosure reports—five times—was simply an "oversight."

## INDICTED FUGITIVE FUNNELS THOUSANDS OF ILLEGAL DOLLARS TO HILLARY'S COFFERS

A wealthy Pakistani businessman who allegedly funneled thousands of dollars in illegal campaign contributions to Hillary fled the country in early March after being federally indicted. According to the FBI: "Between June 2004 and February 2005, [Abdul Rehman] Jinnah allegedly solicited employees, family members, and business contacts to provide campaign contributions to several United States federal and state politicians. Jinnah then allegedly reimbursed the contributors with corporate monies from his own business." Was

Hillary Clinton one of those politicians? Almost certainly. Over the years Jinnah hosted fundraisers for Hillary. Photos of Jinnah sporting fancy three-piece suits, standing next to Hillary provide a contrast to his mug shot on the FBI's "most wanted" list, which Judicial Watch found and posted on our Internet site, [www.judicialwatch.org](http://www.judicialwatch.org). Overall, Jinnah and his family contributed more than \$100,000 to the Democratic Party. He also organized a center that helped form a powerful Pakistani Caucus in the United States Congress.

## HILLARY OUTBIDS OBAMA FOR ENDORSEMENT

In mid-February, Hillary "purchased" the highly pursued endorsement of an influential South Carolina senator who also happens to be the pastor of the state's largest black church. Hillary's main rival for the Democratic presidential nomination, Illinois Senator Barack Obama, also fought for the endorsement, but it seems to have gone to the highest bidder. The Clinton campaign "outbid" Obama by signing a lucrative contract with a public relations firm owned by the senator-pastor, Darrell

Jackson. Just as Obama was on the verge of sealing a deal with the firm, Hillary reportedly doubled the money to \$210,000. The ink was not yet dry when Senator Jackson publicly announced his coveted endorsement of Hillary.

## HILLARY BULLIES COLLEGE INTO KEEPING HER MARXIST THESIS OFF LIMITS

The controversial college thesis that exposes Hillary's Marxist and Socialist views was, until recently, sealed at the request of the Clinton White House to hide the information from the American public. The 92-page document reportedly paints a favorable picture of the radical leftwing community organizer Saul Alinsky, whom Hillary describes as a "compelling personality" with "exceptional charm." The Clintons used their notorious strong-arm tactics to force administrators at Wellesley, a women's liberal arts college in Boston, to create a special rule that made any thesis written by a President or First Lady of the United States off limits. We've seen Hillary take extreme measures to silence her foes. But who could have imagined Hillary could go to such extraordinary lengths to, in effect, silence herself?

## HILLARY QUIETLY SUPPORTS ARAB TAKEOVER OF US PORTS

Hillary toured the country denouncing a controversial deal that would have allowed an Arab government-owned company, Dubai International, to run the operations of certain American ports while a firm operated by her top advisers quietly lobbied for the same Arab company's takeover of two U.S. defense plants. The New York senator claimed national security concerns led her to vehemently oppose the port deal yet refused to explain why her own top advisers were secretly helping Dubai International acquire a U.S. firm that makes tanks and aircraft turbines. Incidentally, Dubai paid Hillary's advisers a hefty \$100,000 to help it get the defense plants. (Dubai has also given a lot of money to Bill Clinton as well.)
