Dear Mr. Althen:

This is a final response to your Freedom of Information Act (FOIA) request to U.S. Customs and Border Protection (CBP). You requested the following:

- The total number of persons smuggled and apprehended for FY2010;
- The total number of smugglers apprehended;
- The total number of smugglers deported;
- The total number of infractions referred to the Justice Department by the Border Patrol;
- The total number of OTM's (Other Than Mexicans) smuggled and apprehended, by country of origin, and;
- The total number of Special Interest Aliens smuggled and apprehended.

A search of CBP databases produced a total of six pages of records responsive to your request. CBP has determined that six pages of the records are granted in full with no redactions. Please note that we were unable to find responsive information for part four of your request.

You have a right to appeal our response. Should you wish to do so, you must send your appeal and a copy of this letter, within 60 days of the date of this letter, to: FOIA Appeals, Policy and Litigation Branch, U.S. Customs and Border Protection, 799 Ninth Street, NW, 5th Floor, Washington, DC 20229-1179, following the procedures outlined in the DHS regulations at Title 6 C.F.R. § 5.9. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS regulations are available at www.dhs.gov/foia.
