

1 any duties for the First Lady or Maggie Williams?

2 A Not to my knowledge.

3 Q Any duties for the Vice President?

4 A No.

5 Q And this is during your tenure. I believe you
6 stated earlier that while you were at the Office of
7 Personnel Security Mr. Livingstone did do some advance work.

8 A Hmm-hmm.

9 Q Can you give us any indication of how often he did
10 advance work, how much time he spent?

11 A I think maybe three times he did it and the
12 longest period of time was two weeks when he went to
13 Normandy.

14 Q So your understanding is that he went to Normandy
15 to do advance work for the trip?

16 A Hmm-hmm. He did the D-Day celebration thing.

17 Q Right.

18 When did you first meet Mr. Marceca?

19 A I think I stated previously at the Presidential
20 Inaugural Committee.

21 Q Do you know when Mr. Livingstone first met Mr.
22 Marceca, did he ever tell you when he first met Mr. Marceca?

23 A He didn't tell me specifically when he first met
24 Mr. Marceca but he did mention that he met Mr. Marceca in
25 his previous advance days on the Mondale campaign.

1 Q Did Mr. Marceca ever discuss with you how he got
2 to know Craig?

3 A No.

4 Q Do you know an individual by the name of Joseph
5 Tarver?

6 A Joseph Tarver?

7 Q T-A-R-V-E-R.

8 A Not to my knowledge.

9 Q Hannah Bond, B-o-n-d?

10 A I don't know, I don't think so.

11 Q Simon Kahn, K-A-H-N?

12 A I have no idea.

13 Q Mark Schulhof, S-C-H-U-L-H-O-F?

14 A No.

15 Q I presume you don't know whether Craig Livingstone
16 knew any of those individuals?

17 A No clue.

18 Q Do you recall any conversations, discussions or
19 memos regarding delays in sending Mr. Livingstone's FBI
20 report to the Secret Service?

21 A Delays that it took so long to get there to the
22 Secret Service?

23 Q Yes. At some point it would have been returned to
24 the White House and then at some later point it would have
25 been sent to the Secret Service.

1 A The files that were kept in our office, as far as
2 our staff goes, were only Lisa and the interns and Ed. My
3 file and Craig's file were kept upstairs, so, we had no
4 control over our files.

5 Q Do you know whether Mr. Livingstone was at all
6 involved in the firings in the travel office employees?

7 A I don't understand how you mean involved. He was
8 director of security. He was told to lock the door and
9 escort the individuals off the White House premises.

10 Q Are you aware of any other involvement?

11 A No.

12 MR. SRERE: Do you need a break?

13 THE WITNESS: No, I'm doing fine.

14 MR. SRERE: Are you almost finished?

15 MR. HIRSHLAND: I think we're pretty close.

16 BY MR. HIRSHLAND:

17 Q Has any request been made by you that the White
18 House or the Department of Justice pay your legal fees in
19 this matter?

20 A I wish they would, but, no.

21 MR. SRERE: Can we go off the record for just a
22 moment?

23 [Off the record.]

24 MR. SCHANZER: Before we start I just want to say
25 for the record that we have a kind of standing objection to

1 the question to witnesses about their attorney's fees. We
2 don't really believe it is an appropriate angle of this
3 inquiry and it's been asked only selectively to certain
4 witnesses. And I just want to note for the record that Mr.
5 Dennis Sculimbrene--in his ex parte interview before the--ex
6 parte meaning majority only interview with the committee--
7 was never asked who was paying his attorney's fees. And as
8 a matter of fact, here is how the interview ended.

9 It says in the transcript and I want to read this
10 into the record: "Obviously your insights have been
11 extremely helpful to us, I appreciate you and your counsel,
12 wife, taking time out of your schedules to come and share
13 your thoughts. ~~If you have any clean-ups, any thoughts in~~
14 the middle of the night you would like to share with us,
15 certainly through Maggie, if we have any thoughts, I hope
16 you don't mind if you will try to reach back and clarify
17 things both ways before. We appreciate your time. We are
18 trying merely to get to the bottom of what actually occurred
19 here. It was a pleasure meeting you."

20 MR. HIRSHLAND: I'd like to reiterate for the
21 record that the exact same appreciation is extended to you.

22 MR. SCHANZER: Let me finish my statement. I
23 didn't mean to imply that we didn't appreciate this witness.

24 MR. HIRSHLAND: You did but we do.

25 MR. SCHANZER: What I was trying to imply is that

1 certain witnesses were not interrogated as to who was paying
2 their attorney's fees, but rather they were invited to call
3 up the majority staff of the committee in the middle of the
4 night if they like and to--

5 MR. HIRSHLAND: As are you, Ms. Anderson.

6 MR. SCHANZER: --share additional thoughts with
7 them. Well, I thought we were doing this in a bipartisan
8 fashion and we were only asking questions on the record,
9 that we weren't talking to witnesses outside these
10 interviews.

11 That said--

12 MR. HIRSHLAND: Ms. Anderson, if you feel the need
13 to add to the record at any point, you should feel free to
14 call the committee and do so. You are certainly invited to
15 as are all witnesses.

16 MR. SCHANZER: Well, that's news to me because I
17 thought we were only doing interviews with witnesses on the
18 record. I would certainly like to know of any other
19 conversations that are going on with individuals about this.

20 MR. SRERE: I might as well put on the record, any
21 communication with Ms. Anderson should be through me and not
22 with her directly.

23 MR. HIRSHLAND: Certainly that will be respected.

24 MR. SCHANZER: I have no interest in retreading
25 over old ground, but the information about Project Update

1 didn't really come out in a particularly chronological
2 fashion. And I didn't understand it and I've been doing
3 this since June.

4 So, if you wouldn't mind, I would like to just go
5 through pace by pace how this thing transpired.

6 When did you first learn that something called the
7 Project Update would need to be done?

8 THE WITNESS: I learned that in August of '93,
9 when Nancy Gemmell was departing.

10 MR. SCHANZER: And what did you learn from Ms.
11 Gemmell at this time?

12 THE WITNESS: That we had to, by law, establish
13 files of every person who was working in the White House at
14 that time. I'm not exactly what the law was but it was
15 something to do with presidential records. And that to do
16 that we had to go off of the permanent task list that Secret
17 Service had, the Uniformed Secret Service and we had to
18 request that. And from that list, we would then find out--
19 and obviously I had this recollection wrong, as was pointed
20 out earlier--that we would find out who was still in the
21 White House, then request the BIs. As I have seen with the-

23 MR. SCHANZER: Why don't we go step by step, okay?
24 Did Ms. Gemmell indicate to you at this time that
25 she had initiated the Project Update already?
