Part VII, line 26 and 46: Over 90% of the shares held in the Reserve Primary Fund were sold and used to buy an equivalent amount in Federated Treasury Cash Trust when the value of the Reserve Primary Fund fell below \$1.00 per share. A small percentage remains in the Reserve Primary Fund pending settlement. This transaction was initiated and carried out by the brokerage company (Ferris Baker Watts/ RBC).
