Your letter of May 7, 2007 refers to two entries on my 2006 disclosure which required more information.

In Part VII, page 5, line 19, T Rowe Price Tax Free Inc. Fund, in which I listed the transaction date for additional purchases as "various," these transactions were from the monthly reinvestment of interest on the account. No single transaction was in excess of \$1,000.

In Part VII, page 8, line 69, I listed "Idearc (from Verizon). This stock was spun off from Verizon (one of the companies listed on my disclosure, as Bell Atlantic (name change Verizon Com., page 4, box 2.)) I do not see an instruction that requires the disclosure to be made any other way. It would have been better to state "spun off from Verizon, see Bell Atlantic (name change Verizon Com., page 4, box 2)"
