As to Section VII, Investment and Trusts:

In 2008 the undersigned continued to change the diversity of its economic portafolio from US/P.R. GNMA and FHL Bonds to Federal Investment Institutions. See lines3-4 (sales); lines 5-8 are Federal Farm Credit Bonds and Federal Home Loan Bond and a Medium Farm Note (Federal) all redeemed. The purchases of Federal Home Mortgage investments, lines 9-11 have been made with the same investments funds lines 3-4 sales, plus from redeemed items at lines 5-8, and from a redeemed investment item in December 26, 2007.

As to Gifts, Section V:

The undersigned pursuant to federal law resigned the honorary membership at Berwind Country Club, a golf country club sporadically used, effective December 31, 2008 and is now a regular paying member of Berwind Country Club. The undersigned also resigned the honorary membership at the Bankers Club effective December 31, 2008 (the later hardly used). No regular membership at the Bankers Club is maintained. The resignation was duly made as required under federal law and within the time limits authorized by law.
