VIII. ADDITIONAL INFORMATION OR EXPLANATIONS. *(Indicate part of report.)*

██████████ is now fully retired, and consequently did not have any income from the firm of Fiddler, Gonzalez & Rodriguez for the year 2011. She is now receiving only Social Security benefits.

Part VII is hereby clarified as follows:

Line 7 constitute an asset that I sold to satisfy a personal debt. The sale represented an asset within my portfolio with UBS. The value of the asset sold had a value in cash of "K," that is, only a few hundred dollars over the "J" value. Hence, the value of "K" is substituted for "J" in Line 7.

The total amount of assets in my UBS portfolio decreased but did not lower the total investment amount, which had then a total of "O" value in cash ("T").

Lines 3 - 5 were assets redeemed by the issuer. Each has a "K" ("T") value. The moneys redeemed were reinvested as stated in Line 6, by purchasing a new security valued at "L" in cash market ("T").

The total amount of the assets redeemed, Lines 3 - 5, total the amount of the purchase price of the new security at Line 6 (within fifty dollars). I simply reinvested the totality of the redeemed assets at Lines 3 - 5 by purchasing a new asset stated at Line 6.

My total assets in UBS in the year 2010 remained at "O" value in cash ("T"). No other explanations are required. The words "parts" at Lines 3, 4 5, and 7 are to be eliminated.

My UBS investment portfolio suffered no changes whatsoever in the year 2011, as to any redeemed, purchased or sold individual assets, nor in total value.

As to my IRA account, I further clarify that both in my 2010 and 2011 Reports, which is the only IRA account the I possess, I do not own individual stocks, bonds or assets. Further, I do not make any investments. The investments of my IRA account with UBS are made at the management discretion of UBS. I own a proportion of assets purchased by UBS of Puerto Rico AAA Bonds Fund, and Puerto Rico Investors Bonds Fund, which investments have a value of "K" in cash ("T").

Finally, letter "D" is eliminated from Part VII, Line 1 of 2011 Report, as superfluous.

As I have no other reportable transactions in my IRA account, my IRA account had a slight increase, but the change it does not alter the "K" value code.
