#### VIII. ADDITIONAL INFORMATION OR EXPLANATIONS

(Incicale part of Report.)

- 1) Part II. The agreement regarding the Wis-onsin Department of E-playee Trust Funds common ed in 1992, when Judge Sykes began employment as a Milwaukee County Circuit Judge. A date of 2003 was inadvertently listed on the Nomination report.
- 2) Part II. The agreement regarding the Wisconsin Deferred Compensation Program was inadvertently listed in this part and in Part VII of the Nomination report. This program is solely listed in Part VII of this report.
- 3) Part V. Item 1. The Union League Club of Chicago is a social and civic association with dining, lodging, and athletic facilities located adjacent to the federal complex in Chicago. The Club offices guest privileges to federal judges. The charge for these limited privileges is currently \$720 a year (he yearly dues for full Club membership is \$2520.00). Members of the federal judicinity who receive such Club privileges may not hold office, serve on continues, or be entitled to vote. Judicial officers with these guest privileges pay for food and athletic services on the same base as Club members.
- 4) Part VII. The trust previously listed as item 8 of the Nomination report was closed in 2003, and a final disbursement was made at that time. This trust is no longer reportable.
- 5) Part VII. The Bank One account previously listed as item 11 of the Nomination report was closed in 2001. A value for this account was inadvertently listed on the Nomination report in Box C.
