In my Financial Disclosure Report for calendar year 2007, I reported the redemption of Expedia, Inc. I reported that Expedia was formerly known as USA Networks. USA Networks acquired a controlling interest in Expedia in 2002. In 2003, USA Networks was renamed Inter Active Corporation (IAC). IAC purchased the remaining interest in Expedia. In 2003, IAC was a holding company. In 2006, IAC was transformed from a holding company to an operating company. I did not realize that upon redemption of the Expedia stock I retained stock in IAC. On August 20, 2008, I received notice that IAC spun off its shares to the following companies: Ticketmaster; Tree.com; Interval Leisure Group, Inc. and HSN, Inc.
