It is not publically traded and I estimated its value to be less than \$1,000. I received a check as a liquidating distribution after it closed and liquidated in 2008.

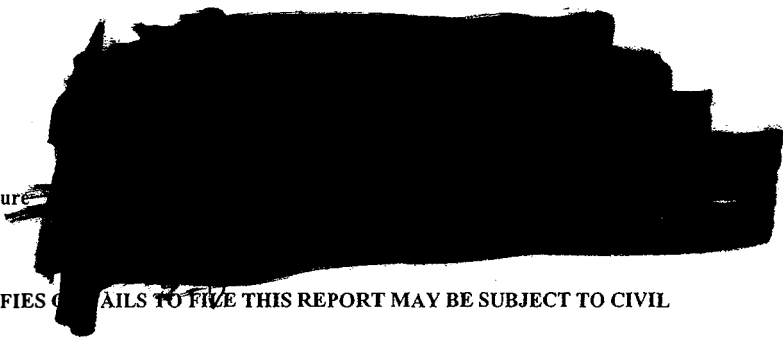
