Part VII. Investments and Trusts

Line 5: There are now two separate IRA accounts. For reporting purposes, they will be referred to as IRA-1 and IRA-2.

Line 8: Agere Systems was listed as Class A and Class B on the 2004 report. In May, 2005, the A and B shares merged, plus there was a reverse split of 1 share for every 10 old shares owned. The odd lot share cannot be held in the account, so it was sold.

Line 29, 30, 31: There are now two separate IRA accounts. For reporting purposes, they will be referred to as IRA-1 and IRA-2. The money market fund (Heritage Cash Trust) on line 29 and the two mutual funds listed on lines 29 and 30 will fall under IRA-2.
