Part VII:

Line 2: The New Dimensions Fund has been acquired by Ameriprise. Also, the income reported last year was inaccurate, due to my misreading of the value codes. It should have been "M" for 2005, as it was for 2006.

Line 15: The Mathers Fund became known as the Gabrelli Fund in 1999. This small IRA was fully redeemed in 2006 and will not appear on the report for 2007.

Line 23: All shares of MGE Energy, Inc. stock were sold on 12-01-06, so this asset will not appear on the report for 2007.

Line 24: AXA Equitable is a mutual fund to which [REDACTED] contributes through monthly payroll deductions at her employment with the Glenview School District.
