Part VII #6 This asset is managed stock accounts that were owned solely by [REDACTED] and of which I will not derive any benefit and of which I have very little knowledge. I have ascertained that the managed accounts were managed for the benefit of hundreds of clients and has over a hundred assets at any one time. Also, the manager of the accounts selects assets for purchase or sale and the participants retain no control over which assets are bought or sold for the group or when these assets are bought or sold. The only control that [REDACTED] retained was to withdraw from the accounts. In January 2006 he elected to withdraw from the accounts. Moreover, because this was an IRA account [REDACTED] received no income in 2005 from the investment.
