As to Part I, the Residuary Trust is invested in mutual funds through Vanguard (total value \$250,000 - \$500,000), [REDACTED] Royal Dutch Shell (total value \$15,000 - \$50,000; dividends \$1,000, or less), mortgage from Jeffrey and Kimberly Kugler (interest income \$5,000 - \$25,000; loan amount \$250,000 - \$500,000); a partnership, One Centennial Square which owns real estate in Haddonfield, New Jersey (income \$15,000 - \$50,000; value \$150,000 - \$250,000), and an interest bearing checking account at Wachovia Bank (income \$1,000, or less; total value \$15,000 - \$50,000). As trustee, I receive no income or anything of value from the Trust and am a contingent beneficiary of the corpus only.
