In Part VII Investments, items 12 through 21 were all held in an MML Investors Services Account, NES/FMTC Rollover IRA, previously listed as "MMLISI Brokerage (Fidelity Management Trust Co.)" The distribution amounts are listed as Income Code F (\$50,000 - 100,000), which is the amount of the combined distributions for all items. The Account manager did not distinguish between line items in making the distribution and that information is not available from the reports to me. The distributions from each of the separate items was less than that amount, but the total was within Code F.
