Corrections for Part VII:

- 1) # 4 - American Capital Inc. BLDR reported for 2011 was deleted because it was a duplicate investment.
- 2) # 8 - IRA 2 - American Capital Income Builder was deleted because it was actually sold on 11/12/11 but was not listed as "sold" on the 2011 report. The report code was "T" at the time of the sell.
- 3) #13 -IRA 1-American Capital Income Builder was reported as sold on 11/2/11 - a Gain Code of "T" should have been listed in Colum D4 for the reporting period of 2011
- 4) #17 -Oppenheimer Global Strategic Income Fund was inadvertently listed as "buy" but should have been listed as "sold" for the reporting period of 2011. The gain code was "B" at the time of the sell
