VIII. ADDITIONAL INFORMATION OR EXPLANATIONS. *(Indicate part of Report.)*

Part I

No assets are reported in Part VII for Estate # 3 because I became Co-Executor in 2007, upon the death of the [REDACTED] under whose will I was appointed. Under the instructions for the 2006 Financial Disclosure Report, for positions, "the reporting period consists of the calendar year preceding the date of the report, and the time to the date of the report." See page 9. The reporting period for assets owned or held by the Estate, however, "is the calendar year preceding the date of the report." See page 35. Because the Estate was not created until 2007, there are no assets to report in Part VII.

The Estate has been designated Estate # 3 to differentiate it from Trust # 1 and Trust # 2, which have been referred to in this and/or prior reports.

The type of income disclosed for Trust # 2 is "Dividend." The form does not allow the filer to report multiple types of income except for the combination of interest and dividends.
