Line #6: Re: IRA Perkins Mid-Cap Value Fund: Under the Internal Revenue Code, a distribution of IRA assets was required; the amount distibuted is indicated in column D(3).

Lines 15 & 16: Selected International Fund was formerly called Selected Special Shares. Although only part of the Selected International Fund was sold on 4/26/11, columns C(1) and (2) are left blank on Line 15 because, as indicated on Line 16, the remainder of that Fund was sold on 7/27/11, and that assset had no value at the end of the reporting period.
