In response to your letter of June 13, 2005 requesting two clarifications of my 2004 Financial Disclosure Report:

1. In future reports I will delete the specific amount of acreage and will list the asset as "1/4 interest in land, Meeker CO., MN" as suggested.
2. With reference to my 2003 report, line 12, Putnam International New Opportunity Fund IRA Account, Column D, should have been reported as "Sold" rather than "Partial sale". I owned no interest in this Putnam fund at any time in 2004.

After a phone conversation with your Committee's administrative office, it is my understanding that this letter will be an amendment to my report and is accessible to the public. If further information is needed to complete my requirement under Section 102 of the Ethics Government Act, please advise.
