Part I. Positions: Further clarification to Answer 2 "Operator".

This is a one-man operation on estate #1 property. I have had cattle. During this reporting period, I kept horses and cut hay on shares with a third party.

Lines 11, 12, 16 and 17: During June, 2006, the entire money market account was transferred from Premier MMKT SHS Govt to Sovereign Bank MMKT by the investment advisor. This change was not reported on the 2006 report.

Line 18: This account closed and assets transferred to rollover IRA.

Lines 30 and 31: On December 31, 2007, Synovus distributed its indirect interest in Total Systems Services ("TSYS") to shareholders, a "spin off."

Lines 52 and 55: This is fixed retirement income. I have control by power of attorney. No value past the death of the beneficiary. (Per instruction VII, Para. C. Income, page 45.)
