SUMMARY OF EVENT:

Cedar Riverside Fire: On January 1, 2014, an explosion and fire occurred at 516 Cedar Avenue South in Minneapolis, Minnesota. The explosion and fire resulted in 14 injuries, 6 of them critical and 3 fatalities. The damage to the structure is estimated at \$1,500,000.00.

NARRATIVE:

1. On January 1, 2014 at approximately 0816 hours, an explosion occurred at 516 Cedar Avenue South in Minneapolis, Minnesota. The explosion resulted in a large fire occurring in the structure. The structure consisted of a grocery store located at ground level and apartments located above the grocery store. Additionally, a mosque was located next door to the affected structure.
2. The ensuing fire resulted in occupants of the apartment jumping out their windows to the ground below. Fourteen (14) occupants were injured during the fire with six (6) of them critically injured. The fire resulted in the complete destruction of the building. After suppression activities were completed, fire officials recovered two (2) bodies from the building. A third victim died several days after the fire as a result of injuries sustained during the fire.
3. Investigators were not permitted to enter into the structure on January 1, 2014 due to the fire continuing to burn.
4. On January 2, 2014, ATF was in contact with the Minnesota State Fire Marshal's Office regarding the fire. Additional ATF personnel were also in contact with members of the Minneapolis Police Department. Plans were made to assist with a scene examination on January 3, once the bodies were recovered and the structural integrity was examined.
5. ATF personnel made plans to be at the scene of the fire on the morning of January 3 in an effort to determine the cause of the explosion and ensuing fire. ATF personnel were notified on the afternoon of January 2 that the City of Minneapolis was intending on tearing down the structure prior to a scene examination taking place. They believed the fire was related to a natural gas leak in the building. The building was torn down and was then turned over to insurance representatives.

So far, here is what I know: A MPD officer was either taking a report or issuing a citation and went back out to the squad car. Shortly after doing this, an explosion occurred at the structure which then resulted in a large fire. The faint smell of natural gas was detected prior to the explosion but at this time no one is sure where it was coming from.

The ensuing fire caused many occupants to jump from upper floors and resulted in several if them receiving injuries associated with the fall. Others received injuries relate to the fire and six of them are listed in critical condition. They are unsure how many may be unaccounted for due to the holiday and not knowing who was all staying in the apartments.

The explosion/fire investigation is set to begin tomorrow depending on the integrity of the structure. In particular, they are set to take a close look at the gas meters along one if the walls in the basement however it was filling up with water and will probably be a mass of ice by morning. I am set to call them again tomorrow to find out how it is going and if they re needing assistance, I may out in a request to fly out on Friday and assist them with the scene. The FBI was somewhat involved in that they are monitoring the investigation (whatever that means). There is a mosque near the scene but is has no involvement in the explosion/fire.

While the ROI that was written for this investigation (778065-14-0020) describes an explosion and resulting fire, this was a fuel air explosion and not the result of an explosives incident. Additionally, at the request of the Minneapolis Fire Department, ATF did not respond to this incident. As there is no CFI currently in the state of Minnesota, an ATF CFI from out of state was planning to assist with the origin and cause of the fire and so an opening report of investigation was written. However, the structure was never deemed safe enough for the investigation to ensue and the CFI never responded to the scene. The fire department ultimately had the building demolished, thus preventing any ATF investigation.

Greetings,

The enforcement of our nation's explosives laws are of the upmost importance to the safety and security of our country. Every day ATF personnel are involved in the security of explosive materials and the investigation of individuals who have utilized explosives for criminal purposes. The National Explosives Task Force (NETF) thanks you for your endeavors on behalf of the bureau and the American public.

As you may be aware, the DOJ, in response to the Inspector General's report, has required that ATF share explosives response notifications with the FBI in a timely manner. These notifications serve not only to notify the FBI but to also keep ATF senior leadership apprised of ATF involvement in explosives related incidents. The Assistant Director (AD), Field Operations has tasked the NETF with monitoring and verifying ATF's compliance with the spirit of the Inspector General's information sharing provisions.

For the Month of January, 2014, the NETF has identified the following case(s) involving an explosive related response or incident within your field division that appears to have required an explosives notification:

The highlighted text in the attached file(s) appears to support the need for an Explosives Incident Notification per the incident reporting criteria; however it does not appear that a notification was made. If this is not accurate, please provide us with your reasoning as to why an explosives notification was not necessary or was not sent to the Joint Support Operations Center (JSOC). Based on the received explanation, the NETF may determine that a notification was not, in fact, required. In this situation, the case will not be included in the NETF's monthly report. If you believe notification was sent to the Joint Support Operations Center, please let us know when that notification was made and by whom.

This electronic message serves as a mechanism to ensure that all appropriate information has been collected and reviewed by the NETF before determining whether or not a field office or field division has notified the JSOC in accordance with ATF Order 3504.1, § 8(b).

Please send your responses to Division Chief (b)(6), (b)(7)(C) at the NETF by close of business on April 18, 2014. If we do not receive a response, we will assume that you agree with the NETF assessment and the case will be included in the monthly report as an explosives incident response for which the explosives incident notification was not sent.
