Dear Ms. Bailey:

I refer to your request letter dated March 4, 2015, regarding the release of certain Department of State records under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552.

The Department has completed a supplemental search of the Office of the Secretary. We have reviewed seven of the records that were retrieved and have determined that one of these documents may be released in full, and six may be released with excisions. All released material is enclosed.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable FOIA exemptions are marked on each document.

FOIA Exemptions
