I'm honored to be here with all of you, to be in this magnificent building, and to have the chance to thank you for the Asia Society's work over many decades to strengthen the relationship between America and the people and governments of Asia.

A half century ago, when the Asia Society was founded, the continent was frozen in a Cold War, racked by poverty, and seemingly destined for desolation. Few in or outside of Asia's borders foresaw anything but a future of conflict, occupation, and despair. Today, the countries I will visit are all at peace. Asia is on the cutting edge of many of the world's innovations and trends; it is a contributor to global culture; a global economic power; and a region of vital importance to the United States today and into the future.

Over the past thirty years I've had the privilege of traveling to a very different Asia. Whenever I think back on those visits, it's as if a movie reel of images old and new starts playing in my mind: the elegant temples of Kyoto; the rituals of nomadic life outside Ulan Bator; the intricate handiwork of traditional craftspeople in Chiang Rai; the vibrant markets of Hanoi and Hong Kong and Dacca; the grand hotels of Singapore and Manila; the calligraphers practicing their art in Xian; the historic dress of Seoul; the traditional dances of Jakarta; the strum of the sitar in New Delhi.

And I've seen skyscrapers and factories; urban corridors and high-tech campuses; research facilities and modern hospitals. A continent where, more often than not, the rule of law and free elections have become – or are in the process of becoming – the norm; where entrepreneurship and innovation have transformed economies into global economic powers.

Asia has influenced world civilization for millennia, as it has our own culture. Our nation is home to 13 million Asian American citizens, and our daily life is enriched by Asian literature and art; music and movies; food, architecture, medicine, science, technology, and values.

I've talked to Channel 4 news today, as has Bager Moin former head of BBC Persian. We are asking for questions to be tabled in Parliament, and for the government to ask questions in Iran on her behalf.

My blithely optimistic thinking remains that Roxana's nightmare is happening against the backdrop of the most positive shake up of US/Iran relations in 30 years; from talks with former tutors in Tehran this is not the headline most Iranian officials want right now; I remain hopeful that Roxana will be released soon.

Bager Moin raised the suggestion that Roxana's sentence may be quid pro quo for Iranian diplomats held by the US on esplonage charges in Erbil in Iraq since 2007. I have no clue if this is true, and I've heard nothing direct about this from Tehran. Any light people can shed on this would be gratefully received.

An event in the life of a nation sometimes has deeper significance than what appears on the surface. The accord by which the government all but ceded administrative and judicial centrol to militants and their Taliban affiliates in Swat is such a development. This has profound implications for the country that have been obscured by the facile discussions on many TV talk shows. It may well mark a turning point in the country's struggle with rising militancy.

The Swat deal signifies several things all at once. First and foremost it represents a retreat for Jinuah's Pakistan. Whatever the apologists of the deal may claim, it is the very antithesis of the vision and ideals inspired by the country's founder, the core of which was a modern, unified Muslim state, not one fragmented along obscurantist and sectarian lines. Several times during and after the struggle for freedom, the Quaid-e-Azam emphatically ruled out anything resembling a throwback to obscurantism or any variant of theocracy. His leadership rested on principle and according to one of his biographers, he preferred "political wilderness to playing to the gallery".

Today the country's established but are led but are led by their dubious interpretation of what the "people want" in Swat, an act of monumental self-deception as any climate of 'opinion' created at gunpoint represents coercion, not consent. Rattled by more aggressive actions by militants, the political and security establishments caved in to the challenge rather than confront it. The Swat deal signalled weakness and hunkruptey on the part of the ruling elite that chose appearement as the pathway to address the country's mounting internal security challenges. While the government showed no leadership or capacity to govern, the country's accurity institutions failed to protect its citizens, and legislators (save for the MQM) preferred expediency to principle. Can any of these actors claim to have upheld Juniah's ideals or
