

1 Q He was also involved in reviewing the BI's of  
2 Project Update individuals.

3 A Yes.

4 Q Was he--for new employees only, my question is,  
5 was he involved in any part of the process that your office  
6 was engaged in?

7 A As I stated before, Tony did not review the new  
8 background investigations that came in. Now, whether Craig  
9 directed Tony to do something as far as the new  
10 investigations, I do not know, nor do I have a recollection  
11 of that.

12 Q Who took over Project Update--

13 A Lisa Wetzl.

14 Q --when Tony left?

15 Do you recall having any discussions in the office  
16 about who was going to take it over?

17 A I believe we had always--when we had sat down, me  
18 and Craig had sat down and talked about Tony leaving, that  
19 he could not--because Craig tried to extend Tony's detail,  
20 and when that was not going to happen, we sat down and said,  
21 well, who are we going to get to do that because, at that  
22 time, I could not do it because I was still concentrating on  
23 getting permanent passes done for the whole White House, and  
24 we decided that Lisa would be the one to take over that  
25 project and that Ed would take up some of her other work.

1 Q Do you know why Mr. Marceca's detail was not  
2 extended?

3 A My understanding was that the Department of  
4 Defense Criminal Investigations could no longer afford,  
5 because of their case work and the amount of case work that  
6 they had--could no longer afford to have Tony detailed to  
7 the White House.

8 Q Do you know if anyone from the White House ever  
9 instructed anyone at the Office of Personnel Security to  
10 order FBI files of former administration officials who no  
11 longer had access?

12 A As in a specific directive to order? No.

13 Q Any knowledge of something less than a specific  
14 directive, maybe a suggestion or a--

15 A None whatsoever at all.

16 Q Do you have any reason to believe that anyone from  
17 the White House ever instructed or suggested that anyone  
18 looked through the files of prior administration officials  
19 who no longer had access?

20 A No, none.

21 MR. SRERE: Let him finish the question--

22 THE WITNESS: I'm sorry.

23 MR. SCHANZER: --so it looks nice on the record.

24 BY MR. HIRSHLAND:

25 Q Do you have any reason to believe that Mr.

1 Livingstone or Mr. Marceca ordered FBI files of prior  
2 administration officials who no longer had access to the  
3 White House for any reason other than to complete Project  
4 Update?

5 A No.

6 Q Did individuals ever visit Mr. Livingstone or Mr.  
7 Marceca at the Office of Personnel Security?

8 A Innumerable times. Could you define what you mean  
9 by visit?

10 Q Well, come to the office to see them.

11 MR. SRERE: Are there specific individuals you  
12 want to talk about?

13 MR. HIRSHLAND: No.

14 MR. SRERE: Did people come into their office?

15 MR. HIRSHLAND: It's an open question and--

16 MR. SRERE: Do people come into the office?

17 THE WITNESS: A lot of people came into the  
18 office.

19 BY MR. HIRSHLAND:

20 Q Do you ever recall people other than individuals  
21 from the--do you remember individuals from outside the  
22 office going into the vault?

23 A No.

24 Q Can you estimate how often Mr. Livingstone had  
25 visitors at the office that you would consider on a

1 non-work-related basis?

2 A I'm sorry. I have to ask you to define visitor.

3 Q Anyone that would show up in the office to say--

4 MR. SCHANZER: Right. Does Mr. Livingstone--he  
5 wants to know if Mr. Livingstone's friends come the office  
6 and Mr. Livingstone--

7 THE WITNESS: Oh.

8 MR. SCHANZER: --invited them into the vault to  
9 look at people's files. I mean, that's what he really wants  
10 to know.

11 THE WITNESS: Well--

12 MR. HIRSHLAND: Well, no, no. That was the prior  
13 question. This question is--

14 THE WITNESS: Friends is a different--I mean, when  
15 you say visitors, we had a lot of people that came into the  
16 office who were from, you know, Office of Presidential  
17 Personnel who had to come in the office and talk to Craig  
18 for various reasons, interns who had to come into the office  
19 and talk to Craig for various reasons.

20 So, when you say visitors, I took it to mean  
21 anybody who came into the office who was not--

22 BY MR. HIRSHLAND:

23 Q Right. In the office.

24 A --staff.

25 Q Yes. And you did so fairly, and you indicated

1 that lots of people did.

2 A Yes.

3 Q And my next question is--I'll narrow it a little  
4 bit. Did people who were visiting either Mr. Livingstone or  
5 Mr. Marceca for other than Office of Personnel  
6 Security-related reasons?

7 A There were a few visits like that, yes.

8 Q Can you tell me roughly how often? Was it daily?  
9 Was it five a day? Was it maybe once every week or two,  
10 some sense?

11 A Once a month, maybe.

12 Q Okay.

13 A But I mean, that's completely an estimate.

14 Q Sure.

15 A I mean, it was not a--

16 Q Do you recall any particular individual, such  
17 individuals? Again, we're narrowing it to people,  
18 non-work-related basis, who would repeatedly come.

19 A His brother came once or twice. Other people who  
20 worked out of--they didn't specifically work with the White  
21 House, but they worked in conjunction with the White House.  
22 Like his best friend, Michael Jones, whenever he happened to  
23 be in the OEOB would stop in to say hey. Jim Denbo, who was  
24 working with the Office of Vice President, on their advance  
25 team, when he came into the White House, would stop by to

1 say hi.

2 MR. SCHANZER: All right. Did either of these two  
3 people that you just mentioned--were they ever allowed in  
4 the vault?

5 THE WITNESS: Not to my recollection.

6 MR. SCHANZER: Were they ever allowed to review  
7 anyone's FBI file?

8 THE WITNESS: Absolutely not.

9 BY MR. HIRSHLAND:

10 Q Do you know who Betsy Wright is?

11 A Yes.

12 Q Do you know whether she ever visited either Mr.  
13 Livingstone or Mr. Marceca at the Office of Personnel  
14 Security?

15 A Not to my knowledge or to my recollection.

16 Q Okay. Could you clarify something for me?  
17 Earlier on, you said at some point that occasionally Mr.  
18 Livingstone himself would take files out of the office, for  
19 example, to Mr. Kennedy, and that would not be indicated in  
20 the log that we discussed.

21 A Uh-huh.

22 Q Do you know if any record would have been kept of  
23 that whatsoever?

24 A To my knowledge, the only time he did take files  
25 out of the office were to either Mr. Kennedy or to Lloyd
