

1 THE WITNESS: I saw one or two of the memos that  
2 she had done and she showed me one of the files that had  
3 been set up waiting for a receipt of the previous  
4 investigation.

5 MR. SCHANZER: Did she indicate to you whether FBI  
6 background summaries had been requested yet?

7 THE WITNESS: Yes. That was the request that was  
8 in the file.

9 MR. SCHANZER: And did she indicate to you at this  
10 time whether she had obtained a list from the Secret Service  
11 to use in conducting the Project Update?

12 THE WITNESS: Yes. She showed me that list and  
13 she also intimated that this was the way it had been done in  
14 the past.

15 MR. SCHANZER: In the past, did that mean previous  
16 administrations?

17 THE WITNESS: Previous administrations.

18 MR. SCHANZER: In your normal operations in the  
19 office, subsequent, prior to that time had you been using  
20 Secret Service pass holder lists for various other types of  
21 activities?

22 THE WITNESS: No. Not pass lists. What we had  
23 ~~been~~ using were access lists. Primarily prior to August of  
24 '55 the main thrust and focus of the office had been making  
25 ~~sure~~ that those people who were on staff had access and that

1 we had a name check completed on those individuals.

— 2 MR. SCHANZER: To the best of your recollection,  
3 did the Secret Service routinely provide the Office of  
4 Personnel Security with an active pass holder list?

5 THE WITNESS: They routinely supplied the Office  
6 of Presidential Personnel with a pass list. I cannot  
7 remember if it was active or if it was a specific active  
8 pass list. I do remember that it included all passes  
9 regardless of whether they were temporary or permanent.

10 That they were supposed to supply it on a monthly  
11 basis.

12 MR. SCHANZER: And would that come on a green and  
13 white computer paper?

14 THE WITNESS: Yes, the big 17 inch.

15 MR. SCHANZER: The integrity of this is important  
16 more than the forms, so, I will just give you a sample page.

17 [Anderson Deposition Exhibit  
18 No. 4 was marked for  
19 identification.]

20 MR. SCHANZER: I'm giving you a form of a list and  
21 this is Exhibit No. 4. Is this the type of active pass list  
22 that they would have been providing you on a monthly basis?  
23 Is it the same format?

24 MR. SRERE: Let me make it clear, there are two  
— 25 different things, Project Update, I believe she testified

1 used a different list which was--

2 MR. SCHANZER: I'm going to get to that.

3 MR. SRERE: Right. But I want to make sure we  
4 understand which list we are talking about.

5 MR. HIRSHLAND: I would also like to clarify I  
6 understood your testimony to be that you weren't certain  
7 whether or not the list was active only or not.

8 MR. SCHANZER: That's not what she said.

9 MR. SRERE: The Project Update list was an active-

10 -/

11 THE WITNESS: Permanent pass.

12 MR. SRERE: --permanent pass list.

13 BY MR. HIRSHLAND:

14 Q Just a moment ago you were talking about other  
15 lists that you received from Secret Service, correct?

16 A Just a moment ago, I was talking about a list that  
17 we were supposed to receive every month and I don't remember  
18 if it was permanent pass, if it was active or de-active. It  
19 was a list that we received every month that had everybody  
20 on it and what pass they held.

21 Q I just merely wanted to clarify that, you said  
22 that you did not recall specifically whether it was active  
23 or inactive.

24 A No, I did not--

25 MR. HIRSHLAND: And your question called it the

1 active list and it was somewhat of a--

2 MR. SCHANZER: Okay.

3 This document I have just shown you, is this the  
4 type of list that you would have received in this format  
5 that you were referring to when you said you received  
6 monthly lists of pass holders?

7 THE WITNESS: To the best of my recollection, I  
8 believe that it is. But I can't say with 100 percent  
9 certainty.

10 MR. SCHANZER: Okay.

11 BY MR. HIRSHLAND:

12 Q Well, for example, if you are uncertain whether or  
13 not it was active or inactive, you don't recall specifically  
14 whether there was a column that would have said active or  
15 inactive, correct?

16 A No. What I'm saying is I believe this may have  
17 been the list that we received monthly but I'm not a 100  
18 percent certain that this is the list we received monthly.

19 MR. SCHANZER: Do you recall receiving lists of  
20 names with this type of format, with a list of names, a list  
21 of numbers, and then a list of something that is at the  
22 right-hand side. Is this the format of the routine lists  
23 you received on a monthly basis?

24 THE WITNESS: Yes.

25 MR. SCHANZER: Do you remember there being other

1 types of information--

2 THE WITNESS: I--

3 MR. HIRSHLAND: Let's go off the record.

4 [Off the record.]

5 MR. SCHANZER: I believe that the pending question  
6 was whether the document you have there, which is Exhibit  
7 No. 4, is the format of the lists that you said that you  
8 would receive on a monthly or other regular basis from the  
9 Secret Service for other functions, other than Project  
10 Update?

11 THE WITNESS: I believe so.

12 MR. SCHANZER: And what would the right-hand  
13 column mean to you on this list?

14 THE WITNESS: That would be the type of pass that  
15 had been issued to the individual.

16 MR. SCHANZER: Okay. Now, when you would receive  
17 these--well, would there be any reason for the Secret  
18 Service to be providing you with lists of people who no  
19 longer had active passes?

20 THE WITNESS: No.

21 MR. HIRSHLAND: Can I interrupt for just one  
22 second?

23 MR. SCHANZER: No, no, you can wait, let me just  
24 finish.

25 BY MR. HIRSHLAND:

1 Q When you said that would indicate what kind of  
2 pass, can you just tell us what those different passes mean?

3 A Well, if you notice that James Baker it says, WHS,  
4 that is a permanent White House pass.

5 Q We don't actually have the same pages. Can you  
6 just tell us what the abbreviations mean?

7 A WHS is a permanent White House pass.

8 MR. SCHANZER: And all the Ts are--

9 THE WITNESS: All the Ts are temporary. Anything  
10 that doesn't have a "T" is permanent.

11 BY MR. HIRSHLAND:

12 Q EOB?

13 A Permanent EOB pass.

14 Q TWHS, Temporary White House?

15 A Yes, Temporary White House.

16 MR. SCHANZER: And then volunteer?

17 THE WITNESS: Hmm-hmm.

18 MR. HIRSHLAND: Okay, great, thanks.

19 THE WITNESS: And like a TWHV is a temporary White  
20 House volunteer.

21 MR. HIRSHLAND: I see, okay.

22 MR. SCHANZER: When you received lists that were  
23 in this format, was the working assumption of the office  
24 that these were active pass holders?

25 THE WITNESS: Yes.
