

1 House, or anyone else, for that matter, learning of that  
2 fact?

3 A Of the fact that--

4 Q That your office had requested and received BIs  
5 for individuals who at that time in fact were not current  
6 passholders?

7 A No.

8 Q Are you familiar with the security tracking  
9 system?

10 A Yes.

11 Q We've had prior witnesses tell us a little bit  
12 about it, so I don't think we need to go into the details,  
13 but I do have one question, which is: Do you know whether  
14 the holdover employees' information would have been entered  
15 into the security tracking system?

16 A At the time that we had that information inputted--

17 Q Which would have been--can you tell us when?

18 A The summer of '94, I believe it was.

19 Q Okay.

20 A The information--if I remember correctly--

21 Q Are you sure it's '94?

22 A Whenever Erin Bertucci was an intern in the  
23 office.

24 Q Okay. We can check that.

25 A That's when it was.

1 Q That's when you first started filling in the  
2 security tracking system.

3 A That computer system.

4 Q That had been all wiped out.

5 A Yes, it was completely blank.

6 Q Okay. So whenever this person was in the office,  
7 okay.

8 A Yes. Well, I take that back. It was not  
9 completely blank. It was completely blank as far as the  
10 White House end of it was concerned. The Chuck Easley  
11 Office of Administration security tracking system had not  
12 been wiped out. That was still current.

13 The system, the way that we had Erin do it, was to  
14 simply take each drawer and each file in that drawer from A  
15 to Z--and Tony kept his updates and Nancy kept her updates  
16 separate--from A to Z were to be put into that security  
17 tracking system. And the poor girl had to sit in front of  
18 the computer from the time she got there to the time she  
19 left, or at least she was supposed to sit in front of the  
20 computer and put this information in.

21 Q So would individuals involved with Project Update,  
22 would their files have been inputted or not?

23 A Their files should not have been inputted. Their  
24 files should have been separate. Now, if one or two of them  
25 had been inputted, I'm not aware of it.

1 Q Okay. We'll end where we started. I started the  
2 whole thing by asking you about your background. We got up  
3 to the White House, and then we've been mucking around in  
4 all that stuff for several hours now.

5 Can you tell us--you described us you've been  
6 involved in events, including the Olympics. Can you tell us  
7 what your employment or other activity has been since the  
8 Olympic Committee involvement?

9 A I haven't had time to look for another job since  
10 the Olympics ended. I didn't end with the Olympics until  
11 the 11th of August, and everybody started calling me  
12 thereafter.

13 Q Okay. So at the present moment, you're not  
14 employed?

15 A At the present moment, that would be correct.

16 MR. HIRSHLAND: I have no further questions.  
17 David, do you?


18 MR. SCHANZER: No.

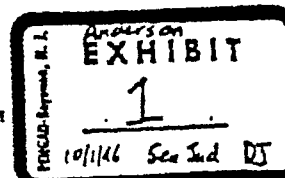

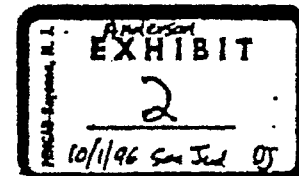
