This will be our first glance into background information of their employees."
Now, are you familiar with this memorandum, Mr. Livingstone?

MR. LIVINGSTONE: sir, it would be helpful for me if it is a multipage document if you wouldn't mind pointing out to me where you are referring to, and i'll be able to quickly answer your question. I'm sorry.
SEN. HATCH: We Kill have somebody come down and show you. MR. LIVINGSTONE: I'm sorry. I'm just trying to help you out. SEN. HATCH: Are you familiar with that memorandum?
