Pursuant to the provisions of the District of Columbia Freedom of Information Act (FOIA), §§ 2-531 *et seq.*, Judicial Watch, Inc. requests from the Metropolitan Police Department access to and a copy of any and all public record(s) within fifteen (15) days pursuant to D.C. Code Ann. § 2-532(c) concerning or relating to the following:

1. Any and all records concerning any arrest and/or booking of Ingmar Guandique, including but not limited to the time and date of each arrest, the time and date of each booking, the location of the arrest, the factual circumstances surround the arrest, the amount of bail set, the time and manner of release or the location where Mr. Guandique was and/ or is being held, and all charges Mr. Guandique was and/ or is being held upon, including any outstanding warrants from other jurisdictions and parole or probation holds.

**Time Frame: January 1, 1998- Present**


