Ken and Ed,

Please see the following report from Phoenix re the seizure of a TNW, 50. Caliber, Semi-automatic rifle. I have attached a photo of which represents the rifle seized.

On August 3, 2010 as part of an ongoing Southwest Border Firearms Trafficking OCDETF [ATF] investigation being conducted by Phoenix Group VII agents seized a TNW, U.S. Government Model HB M2, 50 caliber semi-auto rifle. This firearm sells at retail for over \$12,000.00. This is the second TNW 50 caliber firearm recovered by ATF agents during and in relation to this investigation. This firearm constitutes a substantial increase on behalf of the organization both financially and with respect to firepower; this firearm must be fired mounted on a tripod or vehicle, fires belt-fed ammunition, weighs over 100 pounds and is over 5 feet long.

Dear USAs:

Thank you for your time this evening, I wanted to send this just to summarize our telephone conversation and inform those of you who were unable to participate.

First, thank you for the work you do to fight gun trafficking. It is very important.

As I said on the call, to avoid any potential confusion, I want to reiterate the Department's policy: We should not design or conduct undercover operations which include guns crossing the border. If we have knowledge that guns are about to cross the border, we must take immediate action to stop the firearms from crossing the border, even if that prematurely terminates or otherwise jeopardizes an investigation.

We know you have difficult jobs to do and we fully support and appreciate your efforts to stop the flow of firearms through the apprehension and prosecution of all responsible parties.

As I said on our call, please make sure the SACs in your districts understand the policy.

ATF, we just got back from viewing some guns that were taken last night from a group of gunmen tied to the ATF organization. Supposedly they were on their way to kill the Public Safety Secretary Lt Col ATF when they were intercepted by the State Police (PEP). They were armed with five long guns and five handguns, vests etc .

From examination of the guns these look like the same type of weapons that are coming from Phoenix and that we have been seen in other cases tied to ATF

Below are the guns.

Four of the guns are Romania, Romarm GP WASR 10/63 UP AK-47 type rifles, 7.62X39mm, all had been converted to fire full auto and were in good condition. The Importer, as in the others, is CAI, Georgia, VT. With the following serial numbers:

Son tres rifles de asalto semiautomáticos y una pistola, que llegaron a manos de sicarios del cártel de Juárez o La Línea, como se autodenomina ahora. Con esas armas, aseguradas por el Ejército durante el cateo a una casa de seguridad del grupo criminal en la ciudad de Chihuahua, pudieron haberse cometido más de 100 asesinatos o ejecuciones ordenadas por el grupo criminal que heredó y comanda en la actualidad ATF El Viceroy.

El armamento, entre el que se hallaba un rifle entregado como arma de cargo a un comandante policiaco —que ahora está detenido por servir a los intereses del cártel de Juárez—, fue vinculado a una lista de 96 casos de narcoejecuciones y en las que hubo dobles y hasta triples homicidios. La sospecha es que los tres fusiles y la pistola tuvieran participación en esa lista de narcoejecuciones cometidas en diferentes puntos de Chihuahua.

A la Dirección General de Servicios Periciales de la Procuraduría General de Justicia de Chihuahua (PGJC) se le encargó cotejar el tipo de armas y cartuchos utilizados para cometer los más de 10 asesinatos. Sin embargo, el responsable de esa tarea, el director Pedro Aragonez, fue acribillado durante el transcurso de la investigación.

El crimen contra el funcionario, lo mismo que otros 100 más que se investigan, fue atribuido al cártel de Juárez, cuyos principales operadores en Chihuahua son José Luis Ledesma, El JL, El Mónico, y El Tapicero. Ellos, apoyados por el grupo de ex militares metidos a sicarios conocido como Los Linceos y la red de policías corruptos que los protegen, han desatado una guerra en la entidad contra el cártel de Sinaloa, o los también llamados Gente Nueva, que ha cobrado miles de víctimas en los últimos tres años.

El actual jefe del cártel de Juárez o La Línea, ATF asumió el mando de la organización tras la muerte de su hermano, ATF El señor de los cielos. Desde ese momento hasta ahora ha mantenido un férreo control de la organización, con el uso de la violencia sin límites. Ejemplo del nivel de terror que han impuesto sus acciones en Chihuahua, son precisamente los más de asesinatos presuntamente cometidos con las armas investigadas en este caso.

El aseguramiento La mañana del 17 de febrero de 2008, en el cuartel de la quinta Zona Militar, el general Felipe Espitia Hernández fue notificado de una llamada anónima que ubicaba a un grupo de gente armada en la granja situada en el número 601 de la Calle 87, esquina con la Calle 25, en la colonia Aeropuerto, en la capital de Chihuahua. La voz de un hombre —según el reporte oficial— informó que varios sujetos entraban y salían de ese inmueble con armas.

Fue todo lo que dijo el denunciante anónimo. Con esos datos, de inmediato se dispuso una operación militar para acudir al lugar. Sin embargo, como en casi todas las acciones de este tipo, al llegar los soldados no estaba ya ni uno de los sujetos que fueron vistos con las armas. Pero en su huída, los delincuentes no pudieron llevarse varios paquetes de marihuana, dos vehículos y cuatro armas y cartuchos que fueron asegurados de inmediato.

Lo que llamó la atención del general Espitia Hernández fue la presencia en aquel sitio de un arma larga con

registro oficial ante la Secretaría de la Defensa Nacional (Sedena), además de una serie de documentos oficiales.

Eran recibos de nómina de elementos de la Agencia Estatal de Investigación de Chihuahua, recetas médicas, solicitudes de vacaciones y hasta roles y zonas de trabajo de agentes de esa corporación. El jefe de la zona militar pidió de inmediato la intervención de las autoridades.

El grupo de fiscales y peritos de la PGJC que fue comisionado para recabar todas y cada una de las evidencias elaboraron un informe pormenorizado de lo hallado en el lugar.

Reportaron que además de los documentos oficiales, se decomisaron tres rifles de asalto semiautomáticos y una pistola Smith & Wesson, alrededor de 150 cartuchos útiles de diferentes calibres, una camioneta Suburban color azul, placas DZP 57-37, y una camioneta Toyota blindada, sin placas, de color plateado.

La participación de policías corruptos como parte de la red de protección al cártel de Juárez se veía venir casi de forma natural. Ahí estaban sus nombres, sus pertenencias y hasta un arma oficial. A final de cuentas, en el caso, la Subprocuraduría de Investigación Especializada en Delincuencia Organizada (SIEDO) detendría a seis elementos de la Agencia Estatal de Investigación de Chihuahua.

La investigación de las armas

Sólo hasta 67 días después del cateo en la granja donde se incautaron las armas, el fiscal encargado de la investigación pidió al entonces director de Servicios Periciales, Pedro Aragonez, aplicar los peritajes a las evidencias.

El 25 de julio de 2008 envió al extinto funcionario el oficio 207/2008 para elaborar los análisis de fotografía, planimetría, química, genética y balística, además del cotejo del tipo de armas usadas en 96 narcoejecuciones cometidas entre el 30 de enero de 2002 y el 7 de febrero de 2008.

Casi en forma inmediata, Aragonez informó al fiscal sobre el origen de las armas.

La pistola Browning calibre 40, número de serie 2W5NW50348 y un cargador para 15 cartuchos, fue fabricada en Bélgica por la empresa Smith and Wesson; el rifle de asalto GP WASR-10, con número de serie borrado, provenía de Rumania y podía abastecerse con cargadores de 35 a 45 cartuchos; el rifle Bushmaster XM15, con número de serie borrado y con porta cargadores de 30 cartuchos, fabricado en Estados Unidos; el rifle G36V, fabricado en Alemania por la empresa Heckler y Koch, número de serie 83-0005489, estaba registrado por la Defensa Nacional.

Tres días más tarde —70 días después de hallar del armamento—, el mismo fiscal pidió a la subprocuradora María del Pilar Pérez de la Fuente buscar en los registros oficiales si uno de los tres rifles detectados en el operativo del 17 de febrero era propiedad de la Procuraduría estatal. Ello no obstante que desde un principio el personal Ejército mexicano reportó que existía la probabilidad de que elementos de la Agencia Estatal de Investigación de Chihuahua pudieran estar asociados con el grupo delictivo que habitaba el sitio donde se efectuó el operativo militar.

Una semana más tarde, se agregó a la carpeta de investigación CAI-285/2008 la respuesta de la subprocuradora Pérez de la Fuente. El informe señalaba que el arma larga con matrícula 83-0005489 estaba registrada en la licencia colectiva de armas 192, expedida en favor de la Procuraduría del estado, y lo más inquietante era que ese rifle estaba asignado al agente A de la Policía Ministerial, Luis Humberto Peralta Hernández.

La muerte de Aragonez

La tarde del 11 de agosto, tres meses después de iniciar las investigaciones sobre las armas y la posible vinculación de éstas en las más de 10 narcoejecuciones, el director de Servicios Periciales de Chihuahua, Pedro

Aragonez, fue asesinado por un comando armado.

El crimen se cometió cuando el funcionario viajaba a bordo de una camioneta Durango por la calle de Itzalco, en la colonia El Saucito, en compañía de su chofer que sobrevivió al ataque de los sicarios, que huyeron por la avenida Francisco Villa, en la capital chihuahuense.

El homicidio del director de Servicios Periciales de Chihuahua fue ordenado por El Mónico, de acuerdo con la declaración de Martín Hugo Valenzuela Rivera, El H-8, hombre originario de Durango que fue reclutado por el cártel de Juárez, primero como vigilante de calles y al que posteriormente se le entrenó para asesinar.

Él confesó que estando con El Mónico en Ciudad Cuauhtémoc escuchó cuando fue informado de la ejecución del funcionario. “Vámonos, ya cayó otro”, le dijo su jefe a El H-8 antes de emprender el regreso a Chihuahua. De vuelta a esa ciudad, El Chuma o H-9 le comentó a Valenzuela Rivera que “ya había caído el de servicios periciales. Que le había tocado ejecutarlo cuando se les había perdido a Los Linceos, y que en esa ejecución también participaron de campanas policías ministeriales”

“Era uno de periciales que andaba en una camioneta Durango, que esta persona lo acompañaba su chofer, pero que solamente le había dado al objetivo. El H-9 ha participado en otras ejecuciones, es muy buen tirador. Hemos ido a entrenar tiro a la sierra y disparamos contra pinos o piedras con R-15 o Cuerno de chivo, siempre es muy preciso en sus disparos. He visto sus jales en el periódico”, dijo a los fiscales.

Las “narcoejecuciones”

La primera de las más de 100 ejecuciones ligadas con el narcotráfico en las que pudieron estar involucradas las armas halladas por personal del Ejército mexicano, y que investigaba la Dirección de Servicios Periciales, fue la contenida en el expediente 277/02. Para ello se cotejaban 17 casquillos recogidos en la escena del crimen en la que asesinaron el 30 de enero de 2002 al ex agente judicial de esa entidad Federico Ceniceros Torres, a quien cesaron en aquel entonces por la desaparición de parte de un cargamento de droga confiscado a narcotraficantes en Ciudad Juárez.

El crimen contra Ceniceros Torres, de 39 años de edad, fue cometido con un arma de asalto AK-47, de las llamadas Cuerno de chivo —similar a la que investigaba la Dirección de Servicios Periciales—, cuando se dirigía de Ciudad Juárez a El Paso, Texas, abordo de una camioneta tipo van, Chevrolet, modelo 1989. Una camioneta Dodge Durango se le emparejó y desde ahí le dispararon. La unidad de la víctima chocó contra una malla metálica, a un lado de la avenida Heroico Colegio Militar, casi a su cruce con la calle de Costa Rica, en la zona norte de Ciudad Juárez.

La última de las narcoejecuciones en las que se suponía fueron utilizadas algunas de las armas aseguradas el 17 de febrero de 2008, se trató de un doble homicidio cometido en el estacionamiento del centro comercial Wal Mart de Chihuahua, apenas 10 días antes de que los militares las descubrieran en la granja de la colonia Aeropuerto.

En esa ocasión un comando armado asesinó con rifles de asalto a Osvaldo Loya Carmona y a Nicanor Loya Sánchez, cuando apenas salían del centro comercial y subían a una camioneta pick up Ford línea Lobo, de color rojo.

El doble crimen en Chihuahua aquella mañana del jueves 7 de febrero de 2008 sacudió al municipio de Camargo, ya que la familia Loya es ampliamente conocida e influyente en esa población.

Para aclarar este doble asesinato, los peritos de la procuraduría del estado de Chihuahua, al mando en ese momento de Pedro Aragonez, se encargaban de cotejar los más de 80 casquillos del armamento tipo AK-47 que fueron recogidos por las autoridades en el estacionamiento del centro comercial, ubicado en la avenida Periférico de la Juventud, del fraccionamiento Haciendas del Valle de la entidad, pero hasta hoy se ignora cuál fue el

resultado de las investigaciones de balística forense en todas las narcoejecuciones.

La sospecha es que los tres fusiles y la pistola tuvieran participación en esa lista de narcoejecuciones cometidas en diferentes puntos de Chihuahua.

A la Dirección General de Servicios Periciales de la Procuraduría General de Justicia de Chihuahua (PGJC) se le encargó cotejar el tipo de armas y cartuchos utilizados para cometer los más de 10 asesinatos. Sin embargo, el responsable de esa tarea, el director Pedro Aragonez, fue acribillado durante el transcurso de la investigación.

El crimen contra el funcionario, lo mismo que otros 100 más que se investigan, fue atribuido al cártel de Juárez, cuyos principales operadores en Chihuahua son José Luis Ledesma, El JL, El Mónico, y El Tapicero. Ellos, apoyados por el grupo de ex militares metidos a sicarios conocido como Los Linceos y la red de policías corruptos que los protegen, han desatado una guerra en la entidad contra el cártel de Sinaloa, o los también llamados Gente Nueva, que ha cobrado miles de víctimas en los últimos tres años.

El actual jefe del cártel de Juárez o La Línea, [\[REDACTED\] ATF](#) [REDACTED] asumió el mando de la organización tras la muerte de su hermano, Amado Carrillo Fuentes, El señor de los cielos. Desde ese momento hasta ahora ha mantenido un férreo control de la organización, con el uso de la violencia sin límites. Ejemplo del nivel de terror que han impuesto sus acciones en Chihuahua, son precisamente los más de asesinatos presuntamente cometidos con las armas investigadas en este caso.

El aseguramiento La mañana del 17 de febrero de 2008, en el cuartel de la quinta Zona Militar, el general Felipe Espitia Hernández fue notificado de una llamada anónima que ubicaba a un grupo de gente armada en la granja situada en el número 601 de la Calle 87, esquina con la Calle 25, en la colonia Aeropuerto, en la capital de Chihuahua. La voz de un hombre —según el reporte oficial— informó que varios sujetos entraban y salían de ese inmueble con armas.

Fue todo lo que dijo el denunciante anónimo. Con esos datos, de inmediato se dispuso una operación militar para acudir al lugar. Sin embargo, como en casi todas las acciones de este tipo, al llegar los soldados no estaba ya ni uno de los sujetos que fueron vistos con las armas. Pero en su huída, los delincuentes no pudieron llevarse varios paquetes de marihuana, dos vehículos y cuatro armas y cartuchos que fueron asegurados de inmediato.

Lo que llamó la atención del general Espitia Hernández fue la presencia en aquel sitio de un arma larga con

registro oficial ante la Secretaría de la Defensa Nacional (Sedena), además de una serie de documentos oficiales.

Eran recibos de nómina de elementos de la Agencia Estatal de Investigación de Chihuahua, recetas médicas, solicitudes de vacaciones y hasta roles y zonas de trabajo de agentes de esa corporación. El jefe de la zona militar pidió de inmediato la intervención de las autoridades.

El grupo de fiscales y peritos de la PGJC que fue comisionado para recabar todas y cada una de las evidencias elaboraron un informe pormenorizado de lo hallado en el lugar.

Reportaron que además de los documentos oficiales, se decomisaron tres rifles de asalto semiautomáticos y una pistola Smith & Wesson, alrededor de 150 cartuchos útiles de diferentes calibres, una camioneta Suburban color azul, placas DZP 57-37, y una camioneta Toyota blindada, sin placas, de color plateado.

La participación de policías corruptos como parte de la red de protección al cártel de Juárez se veía venir casi de forma natural. Ahí estaban sus nombres, sus pertenencias y hasta un arma oficial. A final de cuentas, en el caso, la Subprocuraduría de Investigación Especializada en Delincuencia Organizada (SIEDO) detendría a seis elementos de la Agencia Estatal de Investigación de Chihuahua.

La investigación de las armas

Sólo hasta 67 días después del cateo en la granja donde se incautaron las armas, el fiscal encargado de la investigación pidió al entonces director de Servicios Periciales, Pedro Aragonez, aplicar los peritajes a las evidencias.

El 25 de julio de 2008 envió al extinto funcionario el oficio 207/2008 para elaborar los análisis de fotografía, planimetría, química, genética y balística, además del cotejo del tipo de armas usadas en 96 narcoejecuciones cometidas entre el 30 de enero de 2002 y el 7 de febrero de 2008.

Casi en forma inmediata, Aragonez informó al fiscal sobre el origen de las armas.

La pistola Browning calibre 40, número de serie 2W5NW50348 y un cargador para 15 cartuchos, fue fabricada en Bélgica por la empresa Smith and Wesson; el rifle de asalto GP WASR-10, con número de serie borrado, provenía de Rumania y podía abastecerse con cargadores de 35 a 45 cartuchos; el rifle Bushmaster XM15, con número de serie borrado y con porta cargadores de 30 cartuchos, fabricado en Estados Unidos; el rifle G36V, fabricado en Alemania por la empresa Heckler y Koch, número de serie 83-0005489, estaba registrado por la Defensa Nacional.

Tres días más tarde —70 días después de hallar del armamento—, el mismo fiscal pidió a la subprocuradora María del Pilar Pérez de la Fuente buscar en los registros oficiales si uno de los tres rifles detectados en el operativo del 17 de febrero era propiedad de la Procuraduría estatal. Ello no obstante que desde un principio el personal Ejército mexicano reportó que existía la probabilidad de que elementos de la Agencia Estatal de Investigación de Chihuahua pudieran estar asociados con el grupo delictivo que habitaba el sitio donde se efectuó el operativo militar.

Una semana más tarde, se agregó a la carpeta de investigación CAI-285/2008 la respuesta de la subprocuradora Pérez de la Fuente. El informe señalaba que el arma larga con matrícula 83-0005489 estaba registrada en la licencia colectiva de armas 192, expedida en favor de la Procuraduría del estado, y lo más inquietante era que ese rifle estaba asignado al agente A de la Policía Ministerial, Luis Humberto Peralta Hernández.

La muerte de Aragonez

La tarde del 11 de agosto, tres meses después de iniciar las investigaciones sobre las armas y la posible vinculación de éstas en las más de 10 narcoejecuciones, el director de Servicios Periciales de Chihuahua, Pedro

Aragonez, fue asesinado por un comando armado.

El crimen se cometió cuando el funcionario viajaba a bordo de una camioneta Durango por la calle de Itzalco, en la colonia El Saucito, en compañía de su chofer que sobrevivió al ataque de los sicarios, que huyeron por la avenida Francisco Villa, en la capital chihuahuense.

El homicidio del director de Servicios Periciales de Chihuahua fue ordenado por El Mónico, de acuerdo con la declaración de Martín Hugo Valenzuela Rivera, El H-8, hombre originario de Durango que fue reclutado por el cártel de Juárez, primero como vigilante de calles y al que posteriormente se le entrenó para asesinar.

Él confesó que estando con El Mónico en Ciudad Cuauhtémoc escuchó cuando fue informado de la ejecución del funcionario. “Vámonos, ya cayó otro”, le dijo su jefe a El H-8 antes de emprender el regreso a Chihuahua. De vuelta a esa ciudad, El Chuma o H-9 le comentó a Valenzuela Rivera que “ya había caído el de servicios periciales. Que le había tocado ejecutarlo cuando se les había perdido a Los Linceos, y que en esa ejecución también participaron de campanas policías ministeriales”

“Era uno de periciales que andaba en una camioneta Durango, que esta persona lo acompañaba su chofer, pero que solamente le había dado al objetivo. El H-9 ha participado en otras ejecuciones, es muy buen tirador. Hemos ido a entrenar tiro a la sierra y disparamos contra pinos o piedras con R-15 o Cuerno de chivo, siempre es muy preciso en sus disparos. He visto sus jales en el periódico”, dijo a los fiscales.

Las “narcoejecuciones”

La primera de las más de 100 ejecuciones ligadas con el narcotráfico en las que pudieron estar involucradas las armas halladas por personal del Ejército mexicano, y que investigaba la Dirección de Servicios Periciales, fue la contenida en el expediente 277/02. Para ello se cotejaban 17 casquillos recogidos en la escena del crimen en la que asesinaron el 30 de enero de 2002 al ex agente judicial de esa entidad Federico Ceniceros Torres, a quien cesaron en aquel entonces por la desaparición de parte de un cargamento de droga confiscado a narcotraficantes en Ciudad Juárez.

El crimen contra Ceniceros Torres, de 39 años de edad, fue cometido con un arma de asalto AK-47, de las llamadas Cuerno de chivo —similar a la que investigaba la Dirección de Servicios Periciales—, cuando se dirigía de Ciudad Juárez a El Paso, Texas, abordo de una camioneta tipo van, Chevrolet, modelo 1989. Una camioneta Dodge Durango se le emparejó y desde ahí le dispararon. La unidad de la víctima chocó contra una malla metálica, a un lado de la avenida Heroico Colegio Militar, casi a su cruce con la calle de Costa Rica, en la zona norte de Ciudad Juárez.

La última de las narcoejecuciones en las que se suponía fueron utilizadas algunas de las armas aseguradas el 17 de febrero de 2008, se trató de un doble homicidio cometido en el estacionamiento del centro comercial Wal Mart de Chihuahua, apenas 10 días antes de que los militares las descubrieran en la granja de la colonia Aeropuerto.

En esa ocasión un comando armado asesinó con rifles de asalto a Osvaldo Loya Carmona y a Nicanor Loya Sánchez, cuando apenas salían del centro comercial y subían a una camioneta pick up Ford línea Lobo, de color rojo.

El doble crimen en Chihuahua aquella mañana del jueves 7 de febrero de 2008 sacudió al municipio de Camargo, ya que la familia Loya es ampliamente conocida e influyente en esa población.

Para aclarar este doble asesinato, los peritos de la procuraduría del estado de Chihuahua, al mando en ese momento de Pedro Aragonez, se encargaban de cotejar los más de 80 casquillos del armamento tipo AK-47 que fueron recogidos por las autoridades en el estacionamiento del centro comercial, ubicado en la avenida Periférico de la Juventud, del fraccionamiento Haciendas del Valle de la entidad, pero hasta hoy se ignora cuál fue el

resultado de las investigaciones de balística forense en todas las narcoejecuciones.



12 people [arrested], weapons, drugs, money, and trucks seized

The Army presents the weapons and drugs seized and individuals arrested during yesterday's seizure. The national defense secretary, through the 2nd Military Zone, announces the following information to all Baja California residents:

Military personnel from the 23rd Motorized Cavalry Regiment, responding to an anonymous citizen report, stated that at the Colonia Industrial neighborhood in Mexicali, two buses from the Transportes Integrados Mexicanos line went inside, suspiciously, a warehouse, where there were armed men. This resulted in the seizure of: 47 long weapons, one short gun, 57 magazines of various calibers, 340 shells 7.62 caliber 39 mm, and 52 .223 cal shells. Also seized were \$2,126,450 and 868,580 Mexican pesos. A total of 421,600 kg of cocaine and 60,700 kg of methamphetamines were also seized. Three compact vehicles and two buses were seized too, and 12 people holding this merchandise were arrested. The individuals detained are Cuahutemoc Quinoz Luna, 35; Jose Espinosa Flores, 39; Ruben Rocha Bojorquez, 36; Jose Armando Hernandez Iribi, 46; Jose German Madrigal Guzman, 32; Clemente Espinosa Sierra, 31; Francisco Javier Landeros Cardenas, 50; Jose Ismael Alvarez Sicairos, 54; Gonzalo Beltran Beltran, 31; Eduardo Ruiz Bustamantes, 49; and Mariano Garcia Aguilar, 42, all of them from Culiacan, Sinaloa. Additionally Gabriel Izarraga Martinez, 43, from Mazatlan, Sinaloa was arrested.

In its communique, the No.2 headquarters of the military region reports the following: these results reflects the active and decisive participation of citizens, the effectiveness of government agencies like the state's C4, and the effectiveness and timing of the Armed Forces, which means that the people and the government are making progress in the same path and with the same objective. However, for the Mexican Army and Air Force, it is clear that there is still a great deal to be done and that our best ally is the people. Therefore, the troops of the 2nd Military Zone will not take any steps back and will continue fighting with the same energy all around Baja California State to curb drug trafficking and organized crime in all its forms.

Finally, we encourage and invite the people to continue placing its trust in their Armed Forces in order to put an end to drug trafficking and organized crime in Baja California State and recover room for financial and social development. They end by encouraging people to place their anonymous reports at the following number [not given]. This communique is signed by the No.2 headquarters of the military region. 

Eran como las 12:30 horas de este día y tras recibir un reporte del Centro de Control, Comando, Comunicación y Cómputo (C-4), en el que se les indicaba que varios sujetos armados que realizaban detonaciones en las inmediaciones de la colonia Cuauhtémoc Norte.



El operativo llegó a la avenida República de Chile donde no encontraron nada sospechoso, pero por precaución realizaron varios recorridos de vigilancia por la zona y encontraron frente al número 732, en una casa de dos pisos y puerta eléctrica una maleta que se encontraba tirada frente al domicilio indicado y al hacer una inspección minuciosa se encontró lo siguiente: 6 armas largas calibre 7.62X39; 355 cartuchos calibre 7.62X39; 10 cargadores para calibre 7.62X39; y 900 gramos de la droga sintética conocida como "ice". Debido a que les reportaron sujetos armados frente al lugar se tomaron las precauciones del caso, pero sin que se lograra ubicar a persona alguna, por lo que se recogió el armamento, balas y droga, que fueron puestas a disposición de las autoridades correspondientes, quienes se encargarán de realizar las averiguaciones que el caso amerite.



Thank you for the heads up about ATF and the numbers ATF provided me with the necessary stats for Friday's news conference. For your reference, our main stats:

- Criminal cases opened – 176
- Defendants recommended – 66
- # of guns seized – 1285
- Ammo seized – 71,774
- FFL Insp – 806

I will begin working with DAD McMahon to ensure the Phoenix Division uses OSM stats in their handout materials.

Below are the topics the reporter wishes to address (and our general responses are in red). I have also attached a general background sheet that was provided to Dep. Dir. – it includes

material from both GRITs and all of Gunrunner.

The reporter is conducting research with the Washington Post for a story concerning firearms trafficking from the U.S. to Mexico. Topics include:

- The work ATF is doing in the SWB states to prevent illegal firearms purchases (let's look at this as purchases, but also preventing trafficking)
 1. ATF's *Don't Lie for the Other Guy* program and sites where program was offered in last 18 months - El Paso, TX; Anaheim, CA
 2. During FFL compliance inspections, IOIs routinely educate the FFLs concerning detection of straw purchasers
 3. Gunrunner - (see attached)
 4. From fiscal years 2004 through 2009, Project Gunrunner referred for prosecution 1,012 cases involving 2,096 defendants
 - a. Those cases include 510 firearms trafficking cases with an estimated 15,296 firearms trafficked.
 5. Not just SWB states - ATF's Project Gunrunner targets firearms traffickers anywhere in country where the goal is to transport illegal firearms to Mexico
- The challenges ATF is facing in conducting trafficking investigations
 1. (After defining straw purchasers) Identifying straw purchasers during the course of investigation is a challenge - these violations often go undetected (we can never put a number on straw purchased guns - only those we believe are trafficked as a result of our investigations)
 2. The more firearms that are traced - the more valuable leads are developed - more tracing!
- The strategies Mexican "narcotraffickers" are using to traffic firearms
 1. Firearms are being trafficked across the border - vehicle / foot (ATF does not have evidence of large-scale movement of firearms across border - say 1,000 at a time)
 2. Existing drug trafficking routes are prized - and fought over in Mexico
 3. Cartel members are involved in the U.S. to acquire firearms as well as free lance US citizens (looking to make a buck)
 - a. In border states and inland as well
- Coordination with ICE and other federal partners
 1. ATF / ICE attend each other's conferences and share information on best practices and intelligence on criminal investigations
 2. ATF runs the Gun Desk at EPIC - all U.S. LE agencies sharing intelligence
 3. Sharing of intelligence with our GOM partners

The interview is set for 12:00 pm, Wednesday, Sept. 15. I am in the process of securing a conference room (unless you prefer to host interview in your office).

Lanny: We have decided to take a little different approach with regard to seizures of multiple weapons in Mexico. Assuming the guns are traced, instead of working each trace almost independently of the other traces from the seizure, I want to coordinate and monitor the work on all of them collectively as if the seizure was one case. Using the traces as intelligence, and compiling the information from each trace investigation, we can connect the purchases, identify the traffickers and use more serious charges against them. The intelligence analysis and linking of trace data and investigation results will be done at HQ out of our intelligence directorate. I would like to see if you have any interest in assigning a criminal division attorney to work with that group to develop multi-division/district cases and perhaps go to the district with the best venue to indict the case. The level of activity will depend on the number of Mexican seizures, and whether they will trace the guns, or allow us to do it. We do seem to be making progress with our Mexican partners. We are currently working on a case with SSP which might lead us to the first joint arrest in Mexico of a person connect to US arms trafficking. We should meet again just to catch up on where we are in our gun trafficking issues and we could talk about the above idea as well. Let me know what you think. Thanks. Ken.
