I just wanted to keep you all updated on my communication with the Terry family. I called Kelly to give her a heads up that 3 individuals (Jesus Soria-Ruiz, Jose Angel-Camacho, Francisco Rosario Camacho-Alameda) will have their change of pleas tomorrow on illegal entry charges. I told her they were picked up in the general area of the incident but we have no evidence that they were involved in the shooting in any way. I explained that the investigation is on-going and very sensitive right now. Kelly said she had already been contacted by members of the press who had told her that these 3 individuals were going to plea tomorrow, but that we still have one person in custody who was involved. I simply responded that we do have other individuals of interest but we cannot say anything publicly at this time due to the investigation. I sympathized with Kelly and the family whom she says are going increasingly frustrated with the lack of information. I let her know that this case is a high priority for our office and there are currently a lot of resources going into the investigation. She told me that as long as we are all working for justice for Brian she is on board. I told her I would let her know once we had any updates we could share with the family and that we wanted to make sure the family got the correct information from our office and not the media.
