## COUNT 1

From on or about April 30, 2010, to June 3, 2010, at or near Tucson, in the District of Arizona, CHARICE CHAUNTEL GAEDE, EMMANUEL BERMUDEZ VASQUEZ, and ELIAS BERMUDEZ VASQUEZ, knowingly attempted to export and send from the United States any merchandise, article, or object contrary to any law or regulation of the United States, and received, concealed, bought, sold, and in any manner facilitated the transportation, concealment, and sale of such merchandise, article or object, prior to exportation, knowing the same to be intended for exportation contrary to any law or regulation of the United States: to wit; CHARICE CHAUNTEL GAEDE, EMMANUEL BERMUDEZ VASQUEZ, and ELIAS BERMUDEZ VASQUEZ bought, concealed, and facilitated the transportation of 1,500 rounds Russian (Tula) .30 Carbine ammunition, 4,000
