DAG Cole and Acting IG Schnedar: Today ATF announced the formation of a panel to review and

make recommendations as to practices in complex firearms trafficking cases. We released the following statement:

The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) will ask a multi-disciplinary panel of law enforcement professionals to review the bureaus current firearms trafficking strategies employed by field division managers and special agents. This review will enable ATF to maximize its effectiveness when undertaking complex firearms trafficking investigations and prosecutions. It will support the goals of ATF to stem the illegal flow of firearms to Mexico and combat firearms trafficking in the United States.

We will be asking an experienced US Attorney, a prominent non-federal law enforcement officer, a Criminal Division attorney with expertise in gun trafficking cases, an ATF attorney from our Chief Counsel®s Office, an ATF SAC, and a senior ATF manager to participate in the panel®s study. We would also like to have the assistance of one of the authors of the previous OIG Gunrunner report participate on the panel, because of his or her knowledge and perspective on the issues. Thus, I am requesting that you approve an appropriate person from the OIG to participate with us in this review.
