Either late last night, or early this moming, the staff of Congressman McCaul approached ICE to let them know that he intends to have a congressional hearing on the shooting that took place in Mexico, and that they wanted S.A. Victor Avila to testify under oath. ICE pushed back citing concerns about the ongoing investigation, and the Congressman's staff is now considering whether to have a general hearing on the safety of law enforcement officers in Mexico, with Victor present in the audience where he would be recognized as a hero, but without testifying. In any event, the Congressman apparently will have a hearing about this incident in particular or something related to it in the very near future unless he can be convinced to change his mind.

ICE has now referred the Congressman's staff to DOJ for our position, since we are leading the investigation. If it has not happened already, someone is probably reaching out to DOJ at higher levels than mine.
