Hi, Robbie:

Attached is a letter and attachments sent by Sen. Grassley to AG Holder. I'm writing a story for tomorrow. My questions are as follows:

- Are the emails supplied by Sen. Grassley authentic?
- Does DOJ/ATF stand by previous denials that firearms were knowingly allowed to go south of the border as part of Fast and Furious?
- Does DOJ/ATF still deny that FFLs were authorized and/or encouraged to sell guns to suspected straw buyers even after they raised concerns with feeral agents and prosecutors?
- How did firearms purchased during Fast and Furious make it into Mexico? Were those weapons purchased by straw buyers prior to a time when the suspects in question were under surveillance? Were the straw buyers under surveillance but somehow able to evade agents and cross the border? Was it a combination of both? Is there some other explanation.
- Will DOJ/ATF now provide documents requested by Sen. Grassley?
- If yes, when? Also, will the agencies also provide those records to me?
- If no, please explain the refusal to cooperate with a congressional inquiry, and please do not use the "ongoing investigation" claim as an excuse.
- After reviewing Sen. Grassley's letter, the emails, my questions and any other materials you may have, is there anything else that needs to be said or clarified about this matter?
