Sasha: I spoke to USA while we were in Roswell yesterday and he requested that I consult with you on the following:

I was contacted by ATF RAC Brent Quinn, Las Cruces, on 4/27th or 28th, 2011. He had been contacted by his ATF ASAC, George Gillette, Phoenix, who is the ASAC in charge of ATF activities in New Mexico. He asked if Brent would contact me and see if I could speak with his civil attorneys (which he has apparently hired for his committee appearances) regarding Federal Criminal Procedure matters, only mentioning 6 e matters, because he was cooperating with Senator Grassley's committee. He wanted his attorneys to understand criminal procedure to make sure he was not violating anything that could get him into trouble.

I have worked with ASAC Gillette over the years and he has been very helpful getting NM resources for ATF, epically here in Southern NM. I consider him a friend, and I guess he feels the same about me, thus his request through Brent.
