FROM SUBJI	ECT: Explanation of FOIA Exemptions, 5 U.S.C. § 552(b)
	(b)(1) - Allows withholding of information specifically authorized under criteria established by an Executive Order to be kept secret in the interest of national defense or foreign policy and which is in fact properly classified pursuant to such an Executive Order.
	(b)(2) - Allows withholding of information related solely to the internal personnel rules and practices of an agency.
	(b)(3) - Allows withholding of information prohibited from disclosure by another statute.
	The statute is
	(b)(4) - Trade secrets and commercial or financial information obtained from a person and privileged or confidential.
	(b)(5) - Inter-agency or intra-agency memos or letters constituting deliberative material, attorney work product, or attorney-client material.
	(b)(6) - Personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.
	(b)(7) - Applies to information compiled for law enforcement purposes, the release of which:
	(A) - could be expected to interfere with enforcement proceedings;
	(B) - would deprive a person of a fair trial;
	(C) - could be expected to constitute an unwarranted invasion of personal privacy;
	(D) - could be expected to disclose the identity of a confidential source and if the information is compiled by a law enforcement authority in the course of a criminal investigation, information supplied by a confidential source;
	(E) - would disclose law enforcement techniques and procedures or guidelines for law enforcement investigations and which could be expected to risk circumvention of law; or
	(F) - could be expected to endanger the life or safety of any individual.
	(b)(8) - Applies to material pertaining to the regulation or supervision of financial institutions.
	(b)(9) - applies to geological and geophysical information.
