Matt and Colleagues:

That entire case is still sealed and our Superseding listing all the guns has been returned but is not yet public. Arraignment is set for Wednesday, May 25th at 11:00am before MHB at which time we would normally unseal the entire case.

The precise number of guns tied to F and F are 45 of the 46 guns recovered from a BMW car stop were from Fast and Furious, 4 of 7 guns recovered from Hazelwood House search warrant were from Fast and Furious, and 3 of the 7 guns recovered from the San Miguel Search warrant were from F and F, **for a total of 52 out of 60 guns** recovered in the Phoenix Metropolitan area were from Fast and Furious purchasers. These weapons were purchased in Oct, Nov and Dec of **2009. ATF spread sheets are attached.**
