Matt, please see below. We've been advised by the USAO that they don't want serial numbers to go because 1) specific numbers tie the guns to a particular seizure and we don't know which guns are tied to indicted individuals and which ones are tied to individuals not yet indicted; and 2) more generally, providing a list of serial numbers presents the risk of public disclosure, which bad guys could use the numbers to for criminal purposes. That said, we can circle back to the USAO on this, but at the moment, it doesn't appear that we're comfortable producing a list of serial numbers.

Also McMahon was asked about whether F & F was covered in the 4/10 Issa briefing and he said, yes, it was covered.

Based on information we've received so far, on 4/12/11 and 4/13/11, DEA conducted three enforcement actions that resulted in the seizure of 60 firearms in the Phoenix, Arizona area. Subsequent tracing of these firearms and coordination with ATF has revealed that 52 of the recovered firearms can be associated with targets of Operation Fast and Furious. It is important to note that many of the 52 firearms were purchased before the purchasers became targets of the investigation.
