### **Guns From ATF Mexico Program Ended Up in Crimes**

Summary: A Bureau of Alcohol, Tobacco, Firearms and Explosives program that let guns end up with suspected firearms smuggler in an effort to trace the guns to Mexican drug cartel leaders lost track of hundreds of the weapons, many of which had ties to crimes, The Los Angeles Times reported Thursday.

The program made it possible for suspected smugglers to buy 1,765 firearms, 797 of which were recovered in Mexico and the United States after they were used in crimes. Of those crime guns, 195 were recovered in Mexico. And two had links to the December killing of Customs and Border Protection Agent Brian Terry in Arizona.

### **Grassley Asks That Justice IG Be Removed From Probe**

Finally, he said that a previous IG report that was critical of ATF policies may have contributed to the decision to allow guns to be smuggled. "Without a greater level of independence, it will be difficult for the public to have faith in the impartiality and integrity of the result," Grassley wrote.
