Please remind Matt that the clarification I requested was that the information the reporter was seeking about **ATF** was available in the public record -- the Fast and Furious indictment, which repeatedTy names **ATF** and a few other FFLs -- but that it pertained only to that case, not the broader spectrum of our gun cases. I did not comment on the record with this reporter. She called with specific questions about **ATF**, which I assumed were being raised because of the December Washington Post story that talked about **ATF**. We discussed that story, but I told her that we did provide the information to the Post and I couldn't corroborate it, and that I didn't know who the most active gun sellers were in our other gun cases because I wasn't familiar with them (I was still relatively new). This phone call was conducted in mid-March. I think the clarification captures most of this, but might have lost a little in translation as well, so I wanted you to know what I remember saying to her and what I asked her to fix. Below is her email to me after our call where she requests an interview. I did not find a record of me responding to this request in writing, but we did not provide an interview.
