
NARRATIVE:

- On September 23, 2010, ATF S/ ATF reviewed a report by ATF Mexico Attache' Senior Special Agent (SSA) ATF According to S/ ATF on September 10, 2010, the Mexican Military captured four members of a drug trafficking network. One of the individuals is allegedly the ATF At the time of the arrest 502 kilograms of marijuana was also seized along with twenty-six (26) firearms of various calibers. On the same date, ATF S/A ATF examined the 26 firearms and the other seized items.
- 2. SSA Walls' report further states on the above date, at approximately 02:00 hours, **ATF** and his female passenger had been detained at a Military checkpoint on the Tijuana to Mexicali highway.



3. On the same date at approximately 12:00, ATF Tijuana SS ATF and FSN Investigator ATF ATF met with Mexican Army materials of war expert ATF escorted ATF Tijuana to the location where the firearms and drugs and other seized items were being displayed for the media.


