Narrative Title: Report of Apprehension or Seizure

On today's date of January 14, 2010 at approximately 2250 hours, I, Border Patrol Agent (BPA) Sergio Hands was patrolling the area in and around the Columbus, New Mexico. Deming Control advised via radio that the Columbus, New Mexico Port of Entry had a stolen vehicle in custody. They further stated that a SUV and pickup truck were still outstanding. While looking for the possible stolen vehicles, I observed a white Nissan Armada bearing New Mexico license plate number 896NLW driving through the streets of Columbus, New Mexico. When I pulled up behind the vehicle, it began traveling at various speeds and was making sporadic turns as if attempting to elude me. At one point, the vehicle turned into a residence parking area and remained there until I passed the residence. The subjects did not exit the vehicle so that lead me to believe that the vehicle or subjects didn't belong at the residence. Soon after I passed the residence and vehicle, the vehicle then proceeded to pull back out onto the road and follow me at close distance. During this time I, BPA Hands requested a vehicle registration, stolen vehicle and 72 hour lane checks on the Nissan Armada from the Deming Station Radio. The checks returned with the following information:

Vehicle Description: 2004 Nissan Armada, white in color

License Plate: Privacy

VIN: 5N1AA08A84N740012

Registered Owner: ATF Isabel, Privacy

All other checks returned negative.

I then pulled to the side of the street and the vehicle continued to travel passed me. I then pulled back onto the street behind the vehicle. I then engaged my emergency equipment and advised Deming Control that I was performing a vehicle stop. The vehicle yielded on the corner of Broadway and Wisconsin in Columbus, New Mexico. I waited until back-up agents arrived before I approached the vehicle, BPA Efrain Carrillo and Hector Lujan arrived to the scene. Both BPA ATF and I approached the vehicle, as we walked up to the vehicle the driver was exiting the vehicle, I then instructed the driver to remain inside of the vehicle. As BPA Carrillo approached the passenger side of the vehicle he noticed three assault rifles lying in the cargo area of the vehicle. At this point both BPA Carrillo and I drew our service issued weapons and instructed the subjects to exit the vehicle while

<p>keeping their hands visible. We placed both subjects in handcuffs and handed them to other agents who arrived on scene for further questioning. Afterwards BPA Carrillo, Lujan and I proceeded to clear and search the vehicle for possible illegal contraband. We discovered five additional firearms in addition to the three rifles located in the cargo area in the rear of the vehicle.
