From FY 2009 to FY 2010, the United States Attorney's Office for the District of Arizona increased its gun-related felony cases by 8%.

The pace in FY 2011 is blistering. We are filing gun cases in the District of Arizona at a rate of 69% over just two years ago.

AUSA Emory Hurley was the lead federal prosecutor on "Operation Gideon" which resulted in the dismantling of 9 Rip Crews and the arrest of 53 defendants. This Operation targeted violent crews who were terrorizing the Phoenix area through home invasions.

AUSA Hurley won a national award for his work on this

case – the 2010 Project Safe Neighborhood National Awards under the category of “Outstanding Gun Crime Investigation.”
