Dennis is not going to be available, so he asked me to give you this statement. (I heard the governor might weigh in. Can you let me know what she says if she does?)

"The U.S Attorney didn't watch the hearing and has been in Tucson all day in meetings with Mexican prosecutors on unrelated cases, as well as meetings with victims of the Tucson shooting. None of the complaints by these ATF agents, which contradict the facts and our statistics, have ever been raised in the past with this office. Indeed, ATF is on record as commending this office for the outstanding work on gun-related prosecutions and the office has won national awards within the last year. We stand by our record of gun-related prosecutions."

On background (in reference testimony to the effect that our office doesn't pursue gun cases. That's untrue on its face)

The numbers below are from the attached fact sheet. From FY 2009 to FY 2010, the U.S. Attorney's office for the District of Arizona increased its gun-related felony cases by 8 percent (156 to 185). In this current fiscal year, we are already prosecuting 113, which is on pace to be a 69 percent increase over just two years ago. Also, very few reporters have taken a look at the correlated ammunition cases, but several of those are also attached. Tens of thousands of rounds of ammo are being purchased, with no reporting requirements, and are also flowing southbound to Mexico.

Guns and ammunition cases by the numbers

Between October 1, 2010 and March 31, 2011:

- 185 gun related felony cases in Fiscal Year (FY) 2010 (up from 156 in FY09)
- · 113 gun related felony cases in the first six months of FY11
- · Over 82,000 rounds of ammo seized

The award I referred to in the statement was won by AUSA Emory Hurley for his work on the Fast and Furious Case – the 2010 Project Safe Neighborhood Awards under the category of "Outstanding Gun Crime Investigation."
