Jeremy, I'll call you shortly, but here's a quick review of our status at this point -

- 1. We're preparing a cover letter with a disc that will provide to you all of the docs we've delivered to Chairman Issa, since that is our understanding of Chairman Leahy's request. The disc will include the cover letter that accompanied each production batch, which will describe the nature of any redactions in the docs, as well as our concerns regarding any issues then pending. You will note that many of the letters also offer to make available for review at the Department additional documents that contain sensitive information that implicates Department confidentiality interests and, hence, were not delivered to the Committee. HOGR staff have come in to review many of these documents and we would be glad to have you all come in to review them as well at your convenience.
- 2. We also will provide you with the Chairman Issa's letters, including the subpoena of 3/31, and the most recent request letter of 6/8/11; those are the 2 most substantive requests.
- 3. We have worked out agreements with HOGR staff regarding interviews of some ATF employees, although they have interviewed others without our knowledge and/or presence. The interviews are transcribed, and we have had a former AUSA, current ATF Deputy Counsel ATF and OLA's Molly Gaston accompany those witnesses. Greg's role is to protect the Department's interests particularly with regard to pending investigations and assist the witnesses in their official capacities. Molly has been fulfilling OLA's usual role and taken notes. We have agreed that we will not share info from one interview with individuals who may be interviewed later on. No transcripts are going to be provided to us, but we can go to HOGR to review them if we choose.
- 4. These agreements are not set forth in any formal correspondence not sure we have any emails; they've been negotiated with Steve Castor by Matt Axelrod in ODAG and me. Phoenix SAC Bill Newell was interviewed last week and Bill McMahon (will get title) was interviewed today. Former Phoenix Group Supervisor ATF was scheduled for interview tomorrow, but that has been postponed to Thursday, with the understanding that it may run over to Friday morning. He has another commitment on Friday afternoon, which is not a problem for HOGR. We expect additional interviews next week and the following week, but I don't have a reliable schedule yet will try to get that for you tomorrow.
- 5. Matt and I could meet with you on Thursday afternoon if that would work let's figure out a time.
