

This email is to formally request permission from the Phoenix Field Division for a large expenditure of AC funds for case number

firearms. He was sentenced, imprisoned, and is currently out on Federal court for lying in order to acquire firearms. He was sentenced, imprisoned, and is currently out on Federal probation. He has multiple Mexico firearm recoveries in Mexico and is suspected of trafficking weapons again for the Mexican DTO's. Since he is now prohibited he has his "Brother" **Exercise Section** "straw purchasing" his weapons. In June ATF obtained arrest warrants for both individuals. However, the warrants are "sealed" pending a possible ATF UC action. The ATF UC action **can not** happen without the requested AC expenditure.

- DEC Both and and an purchase weapons. **Example** with an invalid CCW bypassing NICS. (14 guns purchased)
- JAN CCW expires and can no longer purchase.
- April **April Methods** burchases over \$45,000 in firearms. (Phx, Scottsdale, Glendale, and Yuma)
- May With assistance of GPS tracker ATF "rips" \$15,000 cash from **sectors** on late night car stop.
- May and orders and pays \$8,000 for belt fed semi-automatic .50 caliber.
- June sector is introduced to ATF UC (sector and booking for tripod.
- June begins ordering Machine guns, grenade s,

has told UC **control** that he is waiting for the .50 caliber before he makes any other purchases. Basically his money suppliers are a little "cautious" because currently they are out \$23,000 (to ATF) and haven't seen one gun come from **control** lately.

The expenditure is for a ".50 caliber simulator". A "non gun prop" that ATF could let walk to **example**. If the "simulator is not recovered in the subsequent search warrants and possibly makes it to Mexico. (ATF would not liable due to it's non "firearm" status) Transfer of this "prop .50 simulator" through his "Straw purchaser" will hopefully identify a storage locker, unknown third party, or house here in Yuma. Two (2) Federal search warrants have already been drafted for the **example** and **example** residences and would be signed prior to delivery. Once **example** (they have there .50 caliber "prop" they have agreed to continue with the prearranged UC deal with UC **example**. This **example** (2) M203 grenade launchers, grenades and additional machine guns...

This requested AC expenditure will hopefully lead to the identification of additional SW location(s) here in Yuma and Phoenix, new unidentified conspirators, the ATF UC deal, seizure of \$125K, which we have a new significant charges for a habitual offender/trafficker.

## The total of the AC expenditure is \$6,500 for the simulator and would be constructed by TNW Firearms. The total of AC expenditures to date for this case is \$ 37.92.
