Dear Mr. Rhodes:

We have reviewed the materials that are slated for release in connection with the July 22, 2009, Freedom of Information Act (FOIA) requests from the Wall Street Journal. We understand that the Department of Defense has decided that it will not redact the names of congressional staff.

We object to this decision, and we believe that the names of congressional staff should be redacted from these documents.

Defense Department policy provides that names of staff below the O-6 level be redacted from FOIA releases. We are aware of the Department's argument that congressional staff should not be accorded the same level of protection from public scrutiny because the Congress has adopted a practice of greater transparency with respect to its personnel. We are not, however, persuaded that this forms the basis for a valid legal distinction.

Accordingly, we ask that the Department redact the names of congressional staff before releasing the documents in question.
