Thank you again for organizing the discussion next week and for the invitation to participate.

I wanted to follow up with you regarding the agenda. As we discussed, you expect to have some folks from TSA and the Intel Analysis unit explain the new directive. It would be great if you could also have someone from CBP/the Secretary provide an update on the internal review of border interrogation and search practices.

As you know, the Secretary committed to Congress that she would conduct an internal review, following the issuance of our report, Unreasonable Intrusions, and concerns raised by members of Congress about questioning and searches of Americans returning home. In August, the Secretary issued a revised

electronic device search policy. At that time, she directed CRCL to provide a civil liberties impact assessment. It is our hope that the internal review of CBP questioning and search practices and policies is not limited to electronic devices/laptops and is extended to questioning, especially decisions about who gets flagged for secondary and the scope of questioning that then takes place. (For your information, I'm re-attaching a memo we submitted to Jim McNeely last fall that summarizes our concerns and specific recommendations for the CLIA.)

I do hope we can get an update on the review of border questioning and search policies. I know this topic is of interest to many Americans, especially Muslim, Arab and South Asian communities.
