**THIRD JOINT STATUS REPORT**

Pursuant to the Court's Minute Order dated November 16, 2009, Plaintiff and Defendant file this Third Joint Status Report in the above-styled case.

**a. The Defendant's Proposed Plan for Processing the Responsive Documents:**

Defendant has collected responsive records and has begun processing these records. Defendant expects to provide a complete set of responsive, non-exempt records to Plaintiff by Thursday, April 15, 2010.

**b. The Plaintiff's Position with Respect to the Proposed Plan:**

Plaintiff is satisfied with the April 15, 2010 deadline for the production of responsive, non-exempt records in this case.

**c. A Suggested Schedule for Proceeding with this Matter:**

The parties respectfully propose the following schedule for proceeding with this matter:

(1) Defendant will produce all responsive, non-exempt records to Plaintiff by Thursday, April 15, 2010.

(2) Plaintiff will review those records to determine whether it will contest any of Defendant's withholdings made pursuant to 5 U.S.C. § 552(b). If, after this

review, Plaintiff determines that it will contest certain withholdings, the parties will confer in an attempt to resolve any dispute regarding these withholdings.

The parties will make every effort to finalize these negotiations by May 15, 2010.

(3) If the parties are unable to resolve a dispute about one or more withholdings, the parties will propose a briefing schedule for cross-motions for summary judgment.
