3. In 2008, our money market fund and mutual funds were with Citibank Smith Barney. Due to mergers, the funds are now with Morgan Stanley Smith Barney.
4. On my 2008 FDR, I listed a sale of American Balanced Fund Class C, but that should have been a partial sale. C1 should have reflected Value Code "J," and C2 should have reflected the Value Method Code 3 as "T".

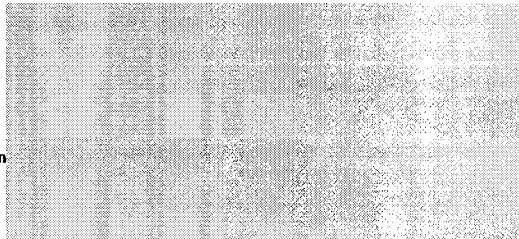
